Technical Specification

Micro Perforated PF of 60µ RW (1100mm)-

Micro perforated plastic film of 60 microns RW (1100 mm)

Application: Micro perforated plastic film will be used for packing of reams.

Reel Width: 1100 mm ± 20 mm.

Film reel diameter: 200 mm ± 25 mm.

Plastic film thickness: 60 microns ± 5 micron.

The plastic film should be made of polythene material having density:

0.913 to 0.937 gm/ml at 27 degree centigrade, as per IS: 2508-1984. Specification of plastic film should be in accordance of IS 2508-1984.

Film quality should be LDPE film of grade 220 confirming to IS:2508-1984.

Micro perforated plastic film should be heat shrinkable.

Distance between perforations: 1.5 ± 0.5 cm.

Internal core diameter: 76 mm.

Core Plug should be inserted in both side of core pipe to prevent collapsing of plastic film reel during storage and transportation.

Other Requirements:

- -The film is to be folded after micro perforations are made to prevent stickiness / adhering of film at the perforations
- -Splicing of film rolls in middle of a roll are not acceptable.
- -The core of the film should not extend beyond 20mm on either side and winding edge of the film should be uniform as possible.
- -The core of film should have label to identify the supplier.

Packing Requirement:

- -Plastic Film rolls packed in corrugated carton box (up to 1000 kgs/pallet) shall be arranged on the wooden pallet.
- -Every stack shall be strapped with plastic strips (along with pallets) to avoid falling & subsequent damages during transit.
- -Every stack shall be wrapped in stretch film (above 50 microns) to form a compact block structure.

- -Each stack shall contain packing list of contained packing materials (number of rolls, capacity of each roll, net quantity, supplier name, batch/lot number, invoice no etc.)
- -Supplier should provide gross weight of each pallet along with weight of packing materials (i.e. empty pallet weight, net weight, other packing materials weight).

Quality Control Requirements:

The supplier shall ensure that the material supplied is manufactured in accordance with the technical specifications mention above.

Laboratory Test: The Laboratory test will be carried out as per specified standards mentioned in Technical specifications.

The lot will be rejected if it fails the above mentioned laboratory tests and no payment will be made for that consignment.

As regards quality, SPM laboratory analysis report will be final and SPM decision on acceptance or rejection will be final and binding or supplier.
