A. General Introduction:-

1. The Scope of work covers Supply, Installation, Testing, and Commissioning of Tower type Air conditioning of 04 TR capacity for Security Paper Mill, Narmadapuram.
2. Nature of works will be supply, installation, testing & commissioning of Indoor cooling, outdoor condensing unit, refrigerant piping etc. and associated electrical engineering work, power / control cables, control panel etc.

Make: - Blue star/Voltas/ Diakin/ Emerson-Liebert / Batliboi / Hiross / Uniflair/ Stulz/LG

Refrigerant: - R410a, R407C, R134A, R32 etc

B. Scope of Work :-

Scope of work includes supply of following item in line item :

1. Supply of Individual Floor Standing Type Tower AC unit air:-conditioning system complete with indoor and outdoor units with accessories of capacity 04 TR
2. Refrigerant Piping: - Supply & fixing of interconnecting copper refrigerant pipe work duly insulated with elastomeric nitrile rubber for A/C piping between indoor and outdoor units. suction pipe line 20 meter and discharge pipe line 20 meter.
3. Control Cabling: - Supply and laying, testing & commissioning of following sizes of Copper conductor control cables effecting proper connections to equipment etc. complete as required 20 Meter
4. PVC Drain Piping: - Suitable size drain piping with necessary support should be provided to remove the condensate water .

Scope of installation, testing & Commissioning :-

1. Installation, testing and commissioning of Tower air conditioner i.e. indoor, outdoor unit and accessories...etc.

2. Electrical Point:

- a. Supply and laying testing and commissioning of copper conductor control cable for proper connection to equipment...etc. complete as required.

b. The scope of work also includes complete assembly and wiring and testing of Tower A/C at site, erection and testing and commissioning of all electrical equipment, supply of all commissioning spares.

Battery Limit: - 3 phases, 415v, 50Hz power supply at isolator shall be provided at one point for Air conditioner. Further distribution including supply, laying & termination of cables shall be in bidder's scope. Trailing/ flexible cables as required for the tower A/C shall be in bidder's scope.

3. Other activities:-

- a. Balancing of the entire Tower Air Conditioning installation.
- b. Cleaning of site & handing over the works.
