- Primary Hydro test shall be performed by the vendor in presence of SPM representatives.
- Inspect the boiler by The Boiler Inspector after completion of work.
- All liaisoning from Director of boilers office including inspection will be in the scope of Vendor only.

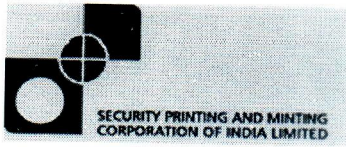
