Brief about Boiler House:

M/s Security Paper Mill is the manufacturer of various security & currency papers and works under Govt. of India. In order to cater to the Steam Demands of the plant for production, Boiler House consisting of 04 Boilers of 10 TPH capacity fire tube boilers is in operation. The Company desires to enter into an annual contract for Operation of two Boilers with a reliable, efficient, experienced contractor in order to provide timely and adequate quantity & quality Steam supply to the Paper Machine Plant at SPM, Narmadapuram

The brief scope of work includes:

The brief scope of work includes: Boilers briefly includes the following Operation activities, working 24 Hours x 7 days (in three shifts) of operation including Sundays and Public holidays as per company's requirement. The Operation of the Boilers should be in line with prevailing IBR rules.

Further, all the works covered hereunder on all the Boiler House machines and systems has to be carried out in strict compliance with prevailing IBR rule.

This specification provides detail scope of services for Oil/Gas fired Boiler Operation along with complete accessories from PLC Control room and at Field. Contractor shall provide all the necessary qualified and experienced manpower for satisfactory Operation of the unit till time period mentioned in special conditions of contract:

1. BOILER SYSTEM

- a. The agency should be responsible for Operation of New Boiler house that consists of two nos. of boiler each having 10Mt/hr. steam generating capacity with Oil /Gas (LPG) fired Boiler and having total heating surface area(including both boiler) 585 m² and its auxiliaries.

1. Three first class attendant certificate holders, three assistant for support of first class attendant having relevant experience are required daily for three shift operation.
2. Total manpower requirement for three shift operation of above boilers (10TPH x2) will be 6 (3 first Class + 3 Assistant of first class).
3. The above manpower will be utilized for uninterrupted 3 shift operation of the boilers as per the instructions of Boiler House in charge.
4. During the maintenance activity of Boiler 5 & 6 then total man power shall be used in preventive maintenance works as per the instructions of Boiler house in charge. However deployment of the above total man power will be done in any shift as per requirement and instructions of Boiler house in charge from time to time.

5. The agency is required to engage qualified /experienced operators appropriately to carry out the works. These people should be engaged in shifts as per the guidance & instructions of Boiler House in charge. The monthly bills will be released as per the actual deployment of manpower.
6. The IBR approved agency should be familiarized with IBR formalities and have to coordinate for IBR approvals if required.
7. The Police verifications and Antecedents of all the manpower being deployed should be checked and verified by the contractor before positioning them at SPM Narmadapuram premises.

4. Monthly Bill payment will be done by ensuring the following:

Ensure round the clock operation of boiler 5 & 6 without fail every month and accordingly payment will be released. Any Loss/damage to the boilers and its auxiliary due to improper operation or maintenance should be recovered from the contractor bills.

5. Scope of SPM:

- I. Payment of fee for statutory requirement to boiler inspectorate for repair work is in the scope of SPM.
- II. Annual cleaning & arrangement for Inspection by director of boilers is in the scope of SPM.
- III. All Corrective/Preventive maintenance is in SPM scope.
- IV. All spares, consumables, logbook etc. will be provided by SPM.

6. Other General information:

- I. The agency is required to do operation activities as per the instructions of Boiler House in charge.
- II. Water, Electrical Power, Detergents, Consumables like cotton waste, lubricants, electrodes, Chemicals, Paints for boiler house auxiliaries & required spares will be supplied by SPM on free of cost.
- III. Considering the above scope of work the agency is required to quote rate per month.
- IV. Before submitting the quotations the agency should understand the scope of work and also can visit the site for further clarifications if any.
- V. Payment of PF, ESI contributions should be made as per rules for Boiler House Operational contract manpower.
- VI. The agency is required to arrange gate passes for their manpower for working days and holidays from time to time.
- VII. The agency is required to provide PPE like safety shoe, helmet, gloves, Uniforms etc. as per the SPM norms.
- VIII. SPM can reduce the manpower at any stage with prior intimation of maximum one month time on grounds of reduction in scope of work, alternate arrangement of manpower or indiscipline of the contract manpower.
- IX. The agency is required to follow all the latest general terms and conditions of SPM.
- X. Any other related additional work for the operation of the system that may be assigned from time to time.
- XI. If breakdowns or loss occurred due to negligence act of contractor worker, the entire repair / replacement cost shall be borne by the contractor

7. TERMS & CONDITIONS OF CONTRACT

- a. The payment will be as per actual quantity prepared, executed and accounted.
- b. In case of delay of payment of wages to the contract labour by the contractor, for more than a week, the contract executing officer will initiate action for payment of wages directly from SPM side and recover the same from the payments due to the contractor along with penalty as decided by the respective product head.
- c. In case, the contractor default/fail to pay wages to the contract labour repeatedly (more than once) the contract executing officer shall take action for payment of wages directly by SPM and contract may be short closed despite blacklisting/banning the said contractor from participating in the future bidding/tendering in SPM
