Scope of Supply:-

1. The development process includes Design, Manufacturing & Supply of Gearbox one to one interchangeable to existing Gearbox along with shrink disc, bearing & other accessories in ready to use condition.

Note- During disintegration of rejected CWBN paper SPM has observed that high impact load acted on gear box and its internal, resulted wear and tear / damaged occurred in internal parts. So, firm may review that said load factor while designing of gearbox and ensure that mechanical service factor should be on higher side (i.e. 2 or higher) to meet the requirement.


