Scope of work

Non-Comprehensive Annual Maintenance Contract (AMC) for the maintenance of PLC SCADA and various field instruments of boilers installed at boiler house of SPM. Two boilers have allen bradley PLC and SCADA system and various field instruments like LT, PT, TT of different makes, while the other two boilers does'nt have any automation but they have various field instruments.

A):- Brief detail of Main Control Panel of automated boilers are given below:-

1. Panel view plus HMIs and operator SCADA CPU and monitors.
2. Micrologix and compact logix PLCs
3. Electronic hooters
4. Stratix Ethernet switches
5. Flex I/O modules
6. Pointed I/Os
7. Power supplies of PLC panels
8. Maintenance of Rockwell model Logix FTV Studio (Factory Talk View)
9. Maintenance of all Contactors, MCC panels, Drives, MCBs, Relays, All indication lamps, bridge rectifiers, limit switches, Position Switches, Push buttons & Push buttons with lamps, Flame eye etc. are in the scope of contactor.
10. Servicing/ replacement of all actuators, valves positioner, Electropneumatic positioners, electrical and pneumatic devices are in the scope of supplier.
11. Servicing/ Replacement of all panel and field instrumentation (PLC, SCADA) and its accessories.
12. Maintenance of all temperature transmitters, Pressure Transmitters, Flow Transmitters, Level transmitters, manifold, conductivity transmitters Rtds, O2 Analyser, Pressure Switches, Auto Calibration units, Thermocouples, Position Transmitters, Pressure reducing valves, Control Valves with actuators, solenoid Valves with accessories, Air pressure regulators.
13. Maintenance of all Panel and field instrumentation along with Filtration plant (softener unit) associated with boiler house.
14. Maintenance of all electrical wiring in panels, field instrumentation is in Scope of contractor.
15. Contractor has to calibrate valves, analyser, other sensors and equipment's when required.
16. Any modification /alteration in location of sensors/ change in software is in the scope of contractor.
17. Any other work explicitly not mentined here but required for the purpose of maintenance in boiler house related to instrumentation and automation.

B) Jobs to be Carried Out by the Contractor:

1. Routine maintenance:- The purpose of the routine maintenance is to make intact condition of the control loop being used for boiler. For the smooth functioning and to minimize breakdown, routine maintenance of boiler's instrumentation and control is to be done once in a month. It should also be ensured that the routine servicing is carried out strictly within the schedule on the availability of boilers.
2. Breakdown maintenance: -In case of failure of any break down in boiler the break down maintenance will be carried out on 24 x 7 basis.

C) Details scope of work for Routine and Breakdown Maintenance will be:

1. This non-comprehensive Annual Maintenance Contract includes cost of preventive and breakdown maintenance i.e. Servicing and replacement work.
2. Servicing, repairing, installation, reinstallation and testing of spare parts will be in the scope of vendor.
3. Firm will have to perform routine inspection, checking and servicing of all control loop once in a month. The service report shall be signed by the user and maintenance department and submitted to boiler house department incharge.
4. The firm personnels will perform preventive maintenance once in a month and also breakdown maintenance on "as and when" required basis of all related field instruments.
5. Vendor has to deploy trained resident supervisor (one no.) and technicians (two nos.) during 09:00 am to 06:00 pm six days a week. However in case of any emergency the personnels can be called at any time (24 x 7) basis including weekly off or Govt. Holiday and they have to be present at site within 1 hour of reporting the issue.

6. The supervisor and technicians should not be below 18 years of age.
7. The minimum qualification for supervisor shall be Diploma and technician should be ITI holder.
8. The min. experience for supervisor shall be 3 years and for technician it should be 2 years .
9. All the relevant certificates related to experience and diploma of the supervisor and technician have to be presented by successful bidder to the SPM and after getting approval from SPM authority , the firm can give joining to them.
9. The weekly offs for supervisor and technicians shall be decided by SPM and will subject to vary as per the requirement of maintenance work to be carried out.
10. In case any one personnel is about to go on leave the same has to be intimated to SPM by contractor in advance and has to depute one substitute in case of leave for more than 1 day.
11. The firm's personnel shall be able to perform minor modifications like addition and deletion of rungs in logic as per FBD/Ladder, retrieving the data/logic back up . Addition or deletion of alarms etc. Troubleshooting on PLC and SCADA of boiler 5 & 6.
12. Complaint / Feedback / Performance report: - The Contractor will maintain all records of the complaints in a Register as well as history card of equipment under maintenance contract with detail specification.
13. The contractor, as the employer of his workmen, shall manage them. In the event of any dispute arising between the Tenderer and his employees, the Tenderer alone is solely responsible for resolving the dispute between them.
14. The contractor shall have full control over his workmen w.r.t determining service conditions, discharge, dismiss, or otherwise terminate their services at any time. The contractor shall be solely responsible for any claim arising out of employment or termination of employment of his employees and for statutory payments.
15. The contractor shall employ only such personnel who are medically fit. The SPM has right to direct the contractor to remove from the premises such of his personnel who may be physically, hygienically, clinically or medically unfit.
16. The Contractor shall comply with all the operational rules and regulations, including safety and security rules framed by the company from time to time wherein the Contractor or his workmen happen to be operating / working. In the event of any of the workmen of the contractor violating any of the said rules and regulations, the Contractor would be required to remove forthwith such workmen from the company's premises.
17. All safety equipment such as safety belts, helmets & other equipment (as required for this work) are to be positioned by the contractor & used as per requirement.
18. Payment for the completion of work will be made quarterly basis. The payment of the each quarter of AMC will be made after providing satisfactory service performance. All related instruments and equipment have been serviced at least once / month and brought to good working condition supported by the concern official's satisfactory servicing report.
19. All tools and tackle to perform maintenance work will be carried by contractor and the related consumable items & spares will be provided by SPM.
20. After awarding of PO to the successful bidder. Successful bidder firm shall provide list of working schedule to perform preventive maintenance of all electronics, instrumentation and control.
21. Failure to execute the job within time shall attract LD clause (0.5% per week of the quarter value if work is delayed)

22 After completion of the Agreement, contractor has to hand over the system in perfect running condition to the department.

23. In case the supervisor and technicians are not able to rectify/identify the problem then the firm has to provide the expert guidance to thier personnels also if required the firm may bring any expert from outside in order to sort out more complex issues at their own cost within 24 hours.

11.2 In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.

11.3 Upon receipt of such notice, the supplier shall, with all reasonable speed replace the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, whatsoever shall lie on SPM for such replaced parts/ goods thereafter.

11.4 In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of SPM.

11.5 If the supplier, having been notified, fails to rectify/replace the defect(s) within a reasonable period SPM may proceed to take such remedial action(s) as deemed fit by SPM, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPM may have against the supplier.
