Detail Scope of Work:-

The scope of work covers supply and painting of structure like pipeline, rack, pressure vessel, ladder, railing, tanks#etc. with synthetic paint/ Epoxy paint in different area of the PM-5, NPP, SPM old plant, boiler, ETP/WTP, AC and Ventilation plant at security paper mill, Narmdapuram.
