6. The above tape belt is critical in nature and failure of supplied tape belt directly leads to production loss. So, supplied tape belt trial will be performed for 72 hours. Installation of tape belt will be in the scope of SPM.

7. Bidder should provide all relevant test certificate i.e. MOC, factory test certificate etc. of tape belt at a time of supply.

8. The MSME bidder should submit their design & drawing, equipment, manufacturing & casting facilities. SPM representative may verify for capability and infrastructure inspection.
