- 1. The equipment shall be able to determine the Folding Endurance of Paper as per Schopper Folder Endurance Method. The equipment shall be motor driven reciprocating mechanism.
- The Schopper Type" Equipment should be suitable for determining the Folding Endurance of all Kinds of paper, foil and films up to 0.25 mm Thickness.
- 3. The equipment should have Digital Counter with memory backup to count number of double folds with measuring range upto 99,999 counts/folds.

 The counter should be HMI controlled and have hold and zero setting. HMI should have minimum 7 inch color display.
- 4. Motor and the counter shall automatically stop when test specimen falls / Breaks.
- 5. Frequency of double fold = 105 to 125 folds / minute.
