1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its

subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Forms of EMD and PBG

2. Destination: Security Paper Mill, Narmadapuram (M.P.)-461005

3. Payment Terms: 100% on receipt and acceptance (suitability) of goods by the SPM, Narmada puram and on production of all required documents by the supplier.

4. Bidder Should Quote Prices Inclusive of GST And All Cost Components Such As Packing & For warding Details, Freight & Insurance Charges upto Destination etc. on FOR Security Paper Mill, Narmadapuram (Madhya Pradesh), India basis only.

5. Liquidated Damages (LD) Clause: If the contractor fails to deliver the goods and/or services or any instalment thereof within the Delivery Period, SPM Narmadapuram shall, without prejud ice to other rights and remedies available to SPM, Narmadapuram under the contract, deduct f rom the contract price, as

Liquidated damages, a sum equivalent to the rate of 0.5 Per cent of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or pe

7. SPM (as Buyer) is liable to deduct TDS u/s 194Q @ applicable rate on goods purchases (if app licable). In case of deduction of TDS under section 194Q; the Supplier (Vendor) need not to cha rge TCS u/s 206C (1H) on invoicing on or after 01.07.2021.

8. Vendor has to submit declaration in specified format *(refer Buyer added Specific ATC)* for th e compliance of Section 206AB of Income Tax Act, 1961. In case of non-submission of declarati on; TDS will be deducted at higher rates (as applicable) as per section 206AB.

9. GST Return: Supplier should file the GST returns for outward supplies in time. In case of any Input Credit Loss to SPM by way of their failure to files GST Returns in time, SPM reserves the right to withhold the payment of further supplies till production of evidence of filling of Return s.

10. Manufacturer Authorization Certificate:

(a) If the bidder firm is manufacturer then firm has to submit the valid registration certificate.

13. WARRANTY CLAUSE:

13.1 The warranty shall remain valid for twelve months after the goods have been delivered to the final destination and accepted by SPM in terms of the contract or for fifteen months from t he date of dispatch from the supplier's premises for domestic goods whichever is earlier.

13.2 In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.

13.3 Upon receipt of such notice, the supplier shall, with all reasonable speed replace the defe ctive goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take o ver the replaced parts/goods after providing their replacements and no claim, whatsoever shal I lie on SPM for such replaced parts/ goods thereafter.

13.4 In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a furth er period of Twelve months from the date such rectified/replaced goods starts functioning to t he satisfaction of SPM.

13.5 If the supplier, having been notified, fails to rectify/replace the defect(s) within a reasona ble period SPM may proceed to take such remedial action(s) as deemed fit by SPM, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, w hich SPM may have against the supplier.

14. Splitting may be done among maximum Two (02) Bidders in the ratio of 70:30 of the Total Bid quantity.

8. Warranty

Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 11. Creating bid for items from irrelevant categories.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the
