1 The warranty shall remain valid for twelve months after the goods have been delivered to the final destination and accepted by SPM in terms of the contract or for fifteen months from the date of dispatch from the supplier's premises for

domestic goods whichever is earlier.

- 2. In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.
- 3. Upon receipt of such notice, the supplier shall, with all reasonable speed repl ace the defective goods or parts thereof, free of cost, at the ultimate destination . The supplier shall take over the replaced parts/ goods after providing their repl acements and no claim, whatsoever shall lie on SPM for such replaced parts/ go ods thereafter.
- 4. In the event of any rectification of a defect or replacement of any defective g oods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of SPM.
- 5. If the supplier, having been notified, fails to rectify/replace the defect(s) within a reasonable period SPM may proceed to take such remedial action(s) as deemed fit by SPM, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPM may have against the supplier.

Make- Climatrol Model- KCN463, Storage capacity - 120 liters Body Material: Stainless Steel

Refrigerant: R-134a Type: TOP open

Scope of work: - Repairing of water tank cooling coil, insulation, filter dryer and other supporting accessories.

- 1- Replace old leakage copper pipe line of size of 5/16"(gauge 1mm), Length 90 feet (Approx.) by new line through soldering.
- 2- Firm will have to insulate copper line by PU insulation (Thickness-35mm).
- 3- Replace old filter dryer by new filter dryer.
- 4- Leakage test to be done of complete system after completion of work and water storage tank have to install in water cooler.
- 5- Vacuum all the system to remove moisture and other impurity from inside of refrigerant circuit and fill refrigerant.
- 6- Lifting and shifting of water coolers in the mill premises and out from mill premises shall be firm's scope of work.
