1. - 4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. SCOPE OF WORK:

- 1. The contractor shall do periodically servicing i. e once in every three months during the entire period of contract.
- 2. The AMC is for preventive as well as for break down maintenance and includes repair and replacement of the following parts free of charge during the AMC period.
- A. All electrical parts:- Replacement of SMPS, Pump, solenoid valve, UV lamp, UN holder, Micro switch, LPS, HPS and wiring harness etc as and when required.
- B. All mechanical parts: Replacement of UV champer, float valve, clamp, acrylic sheet, tap, tee, faucet adn SS valve, RO housing component etc as and when required.
- c. All consumable parts: Replacement of pre carbon filter & Post carbon filters at least once in a year. Quarterly replacement of pre-filter and sediment filter. Any other plastic parts/ spares related to RO system not mentioned above. At least one replacement of all filters in an year is necessary.
- 3. It may be ensured that rates for parts of authorized brand only should be quoted and supplied for repair and AMC accordingly. In case if it is found at a later stage that sub-standard/ inferior quality items supplied, necessary action will be taked against such supplier.
- 4. No spares , consumables and manpower will be supplied by SPM
- 5. Servicing shall be carried out at least four times in a year. However, the firm representative shall have to visit and attend the repairs as and when the breakdown occurs on any one of the water purifiers.
- 6. The firm shall have to clean, check and adjust the water filter every time during their visit.
- 7. In case of any compliant / breakdown/ fault in any equipment, the firm has to attend the fault within 1 days of reporting on phone / email.
- 8. The firm shall be responsible for any injury or damage or accident that may be caused to him/ his person or materials during execution of this work inside or outside the SPM premises.
- 9. Service book shall have to be maintained at SPM.
- 10. Checklist of RO service to be pasted or displayed on the RO machine.
- 11. The firm shall clean the storage tank connected with RO filter in each quarterly service.
