## **Technical Specification**

Hiring an agency for disposal of depleted radioactive sources PM147 & Fe55 . The activity of sources are 18.5GBq and 3.7 GBq respectively.

1. Scope of work : Source Disposal of unused accountable radioactive sources to be disposed-off according to RCO (Radiological Control Organization) instructions, as per set guidelines of AERB.. The sources are Decommissioned from machine and kept in a box isolativly inside the premises only.

2.

Scope of activity for disposal of disused radioactive source.

- a) Monitoring real time "Radiation Level" of each source prior to packing.
- b) Leak test/wipe test to be carried of each source prior to packing.
- c) Packing of source in approved/suitable Lead containers and measuring transport index.
- d) Packing of entire source along with source holders in wooden container with lead shielding.
- e) The firm has to depute one qualified RSO for inspection of disused/depleted source. The radiation level will be monitored followed with Leak Test and packaging
- f) Since this material is non stackable as per AERB norms, it should be directly handed over to BRIT.

g) rest all other arrangement for loading and safe transportation to authorized waste management facility (BRIT) has to be made by successful firm on turn key basis.

h) All the required per mission/approvals from AERB/competent authority are to be aquired by the successfull bidder.

i) All the entire activity inspection,packaging, transporation and handed over to BRIT competent radioactive waste management facility shall be supervised and controlled by successfull bidder.

g) For safe removal,transporation and disposal of nucleonic gauges, the bidder shall follow all norms/procedure that have been approved by AERB/competent authority.

h) All documentation shall be in the scope of bidder.
