12.5 If the supplier, having been notified, fails to rectify/replace the defect(s) wit hin a reasonable period SPM may proceed to take such remedial action(s) as de emed fit by SPM, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPM may have against the supplier
