

- Three Pole Changeovers of Socomec / L&T / C&S or equivalent make confirming to relevant IS Code.
- 2. Panel should have Analog ammeter and Voltmeter with CTs, ASS & VSS of suitable ratings for all 5 Changeovers to measure three phase current and Voltage at incoming of all changeovers.
- 3. Panel should be internally wired completely using suitable Control Supply MCBs.
- 4. Panel Fabrication should be of Seven Tank processed powder coated, vermin and damp proof, 1.6/2.0 mm sheet Steel IP55 Enclosure cabinet Siemens grey color of size 1350(W) x 1800(H) x 350(D) mm.
- 5. Bottom side Cable entry for all incoming and outgoing cables, as per drawing shown below with Suitable Gable gland plates.
- 6. Earthling Terminals for double Earthing arrangement.
- 7. Extended terminals should be provided for termination of incoming and outgoing cables on Changeovers.
