- 1. ## 2. Generic

#### 3. Certificates

#### 4. Past Project Experience

**Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. ## **Experience & Past Performance:**

(i) For Manpower Services the bidder should have experience of having successfully supplied the manpower services of 6132 man-days of annual requirement or tender requirement, whichever is less, in any one of the last five years ending on 31.03.2023.

# Capability Equipment & Manufacturing Facilities:

The bidder must have capability to provide the relevant services

## Financial Standing:-

- 1) The average annual financial turnover of the bidder during the last three years, ending on '31.03.2023', should be at least 46, 91,409.24 of annual requirement or tender requirement, whichever is less 31.03.2 023 as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India or equivalent in relevant countries.
- 2) i) The net worth of the Bidder should not be negative on 31.03.2023 and also ii) should not have erode d by more than 30% in the last three years, ending on 31.03.2023.

**Note 2: (i)** For MSEs and Start-ups (registered for the tendered item) all financial criteria shall be exempte d. However, its capacity and capability may be verified (if necessary) by the respective unit as per the standard format included below (at point D)

(ii) Start-up Enterprises: Requirements of prior experience and turnover would be relaxed for Start-up ent erprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups may be either MSE or otherwise.

#### **SAFETY PRECAUTIONS:-**

- a) The Service Provider shall observe all applicable regulations regarding safety on the Buyer's premises.
- b) The Service Provider shall ensure proper safety of all the workmen, materials, pl ant and equipment belonging to him or to Buyer or to others, working at the Buyer's premises.
- c) The Service Provider shall not interfere or disturb electric fuses, wiring and othe r electrical equipment belonging to the Buyer or other Contractors under any circums tances, whatsoever, unless expressly permitted in writing by Buyer to handle such fuses, wiring or electrical equipment.

- (ii) No employee shall be given a new assignment of work unfamiliar to him without proper introduction as to the hazards incident thereto, both to himself and his fellow employees.
- (iii) Under no circumstances shall an employee hurry or take unnecessary chance w hen working under hazardous conditions.
- (iv) Employees must not leave naked fires unattended. Smoking shall not be permit ted around fire prone areas.
- (v) Employees under the influence of any intoxicating beverage, even to the sligh test degree shall not be permitted to remain at work.
- (vi) The employees when working around moving machinery must not be permitte d to wear loose garments.
- (vii) Safety shoes are recommended when working in shops or places where materials or tools are likely to fall. Only experienced workers shall be permitted to go behind guard rails or to clean around energized or moving equipment.
- (viii) The employees must use the standard protection equipment intended for each j ob. Each piece of equipment shall be inspected before and after it is used.

Note: - Successful bidder must provide all PPE kit (Safety shoes, I-card and uniform is compuls ory) necessary as per given job and follow the safety norms of factory to all employee provide d in Mill Area as per the factory rules.

#### 6. Payment

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

## Discl...mer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्ते</u>, conditons stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
