1. Required Terms of Delivery: F.O.R. Security Paper Mill Narmadapuram (Duly Unloaded).

2. Destination: Security Paper Mill, Narmadapuram (M.P.)-461005

3. Bidder Should Quote Prices Inclusive of GST And All Cost Components Such As Packing & Forwarding De tails, Freight & Insurance Charges upto Destination etc. on FOR Security Paper Mill, Narmadapuram (Madh ya Pradesh), India basis only.

4. Liquidated Damages (LD) Clause: If the contractor fails to deliver the goods and/or services or any i nstallment thereof within the Delivery Period, SPM Narmadapuram shall, without prejudice to other rights a nd remedies available to SPM, Narmadapuram under the contract, deduct from the contract price, as Liqui dated damages, a sum equivalent to the rate of 0.5 Percent of the delivered price of the delayed goods an d/or services along with applicable GST of 18% on the LD amount for each week of delay or part thereof un til actual delivery or performance, subject to a maximum deduction of the 10% (plus GST on the LD amoun t) of the delayed goods or services.

8. GST Return: Supplier should file the GST returns for outward supplies in time. In case of any Input Cred it Loss to SPM by way of their failure to files GST Returns in time, SPM reserves the right to withhold the pa yment of further supplies till production of evidence of filling of Returns.
