- 1. 2. Warranty

- **8. GST Return**: Supplier should file the GST returns for outward supplies in tim e. SPM reserves the right to withhold the payment of further supplies till produc tion of evidence of filling of Returns.
- **9.** Bidder shall submit duly seal & signed copy of Technical Specifications and D rawing.

10. WARRANTY CLAUSE:

- 11.1 The warranty shall remain valid for twelve months after the goods have be en delivered to the final destination and accepted by SPM in terms of the contra ct or for fifteen months from the date of dispatch from the supplier's premises f or domestic goods whichever is earlier.
- 11.2 In case of any claim arising out of this warranty, SPMCIL shall promptly noti fy the same in writing to the supplier.
- 11.3 Upon receipt of such notice, the supplier shall, with all reasonable speed re place the defective goods or parts thereof, free of cost, at the ultimate destinati on. The supplier shall take over the replaced parts/ goods after providing their r eplacements and no claim, whatsoever shall lie on SPM for such replaced parts/ goods thereafter.
- 11.4 In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of SPM.
- 11.5 If the supplier, having been notified, fails to rectify/replace the defect(s) wi thin a reasonable period SPM may proceed to take such remedial action(s) as d eemed fit by SPM, at the risk and expense of the supplier and without prejudice

to other contractual rights and remedies, which SPM may have against the supp lier.

11. Liquidated damages : Subject to GCC clause 28, if the supplier fails to deliver any or all of the goods or fails to perform the services within the time fra me(s) incorporated in the contract, SPMCIL shall, without prejudice to other righ ts and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the ½% percent of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract.
