3. Bidder Should Quote Prices Inclusive of GST And All Cost Components Such As Packing & Forwarding Details, Freight & Insurance Charges upto Destination etc. on FOR Security Paper Mill, Narmadapuram (Madhya Pradesh), India basis only.

4. Liquidated Damages (LD) Clause: If the contractor fails to deliver the goods and/or services or any installment thereof within the Delivery Period, SPM Narmadapuram shall, without prejudice to other rights and remedies available to SPM, Narmadapuram under the contract, deduct from the contract price, as Liquidated damages, a sum equivalent to the rate of 0.5 Percent of the deliver

Annexure-I

Supply, Installation, Testing and Commissioning of Local Area Network (LAN) in Administrative Building

1. Introduction

Security Paper Mill, Narmadapuram is looking for a complete solution for installation and commissioning of Dedicated Infrastructure i.e. Local area Network (LAN) for Internet Connectivity and thus providing high connectivity, scalable, reliable, secure and robust network architecture. The Scope of work includes Supply, Install, Test, Commission and support (SITCS). The purpose is to strengthen the Internal Network System for the purpose of higher reliability, speed and bandwidth to the end user within administrative building. The network shall be scalable as well as flexible so that future expansions and enhancements can be made in keeping with the rapid growth of technology and growing demands. In detail, the bidder has to comply with the following scope:

2. Scope of work

- I. Scope of work includes supply & Installation commissioning, Trial, Testing, engaging of labours, support, comprehensive warranty and any other material and civil work required to complete the work in all respects on turnkey basis.
- II. Approximately 67 nos. Data points spreading all over administrative building. All necessary LAN wiring, electrical work required if any will be under the scope of supplier.
- III. The LAN cabling works must be carried out using a structured cabling design with proper labelling of cables at ends, crimping of cables, fixing of patch panels, and proper fixing of LAN cables in PVC conduits.
- IV. Uninterrupted power supply (UPS) to be provided to all active LAN elements to ensure interruption free operations during temporary power failure. UPS will be provided by SPM.
- V. Repair/refurnishing work owing to damage caused due to cabling or any other work related to this project. There should not be any hanging or uncovered wire.
- VI. Supply, Installation and commissioning of all the network components listed in Bill of Materials (BOM) should be carried out by the vendor.
- VII. All the network switches shall be from same OEM and interoperable with existing Switches which are of make CISCO.
- VIII. Bidder shall ensure that the entire proposed/offered model of Network Switches and components should be of latest model and not have End of support in succeeding 5 years.
- IX. Supply and deployment of networking components in CAT-6 standard with all related components from server room to work area with proper connectivity plan complying for smooth uninterrupted connectivity.
- X. Firm should label all the Network points for easy tracking in future.
- XI. Network Documentation (Hard copy in the form of spiral and soft copy) for the CAT 6 Cable Layout throughout the entire admin building and the certified documents should be handed over to SPM Narmadapuram within 1 month after completion of entire job.
- XII. The agency should provide the required equipment and shall bear all the cost on account of development and setting up required infrastructure for the said services. The agency shall submit the details of drawing for approval prior to commencement of entire work.
- XIII. Any structure, permanent or temporary, dismantled or destroyed during the execution of the work shall be refilled/remake or restore to its original condition by the bidder at his own cost.
- XIV. Detailed Bill of material included in this tender is given as **Annexure-II**. However, SPM reserves the right for quantity variation due to increase/decrease in requirements. The bidder shall also provide all required equipment which may not be specifically stated herein but are required to meet the intent of ensuring completeness, maintainability and reliability of the total system covered under this specification, including integration and interoperability with the existing LAN.
- XV. Since this is a turnkey basis project, all the required hardware and software with license which comes in the scope of the project will be provided and installed by the firm.
- XVI. All safety and security norms must be followed during the execution of the work.

3. Scope of Documentation

- I. Providing Original manuals from OEM of all hardware items supplied

- II. Documentation on Equipment/Rack layout plan, complete cabling system layout, network diagram with IP Schema etc.
- III. License documents for hardware/software, if any
- IV. Acceptance test reports, performance test reports of networking components.

4. The firm has to provide onsite training for at least 3 days to SPM team for handling of the network System.

5. Indicative layout of proposed LAN :

6. Network Architecture

- a) Firm shall be responsible for the planning and design of the access network architecture to meet the technical, capacity and service requirements.
- b) Firm shall plan for high availability, reliability and redundancy of the access network elements to meet the requirements.
- c) Firm shall be responsible for providing and executing Cabling, testing etc. without affecting the aesthetics and regular office work at SPM.

7. Warranty and Support:-

- I. Warranty period start from the day of Final acceptance date.
- II. The entire active and passive components supplied as the part of project shall have 3 years onsite warranty from the date of FAC (Final Acceptance Certificate).
- III. During the warranty period all items if required shall be replaced by same make/model. In case defective item model is EOS (End of sale/support) then it should be replaced with equivalent model or higher model of same make/OEM.
- IV. All complaints during the warranty period should be logged within 4 hours of complaint and should be resolved within 48 hrs. Of complaint lodging. 8. Final Acceptance Criteria:

- b) Trouble free operation for at least 10 days.
- c) Complete documentation
- d) Verification and testing of installed data points.

9. Participated bidders need to visit the site mandatorily before submitting the offer. Certifi

cate of site visit (Annexure-IV) should be submitted along with bid. And the offer will be evaluated accordingly.
