- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 1. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

2. Generic

Installation, Commissioning, Testing, Configuration, Training (if any - which ever is applicable as per scope of supply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller.

3. Generic

Manufacturer Authorization: Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. Warranty

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

- 1. Required Terms of Delivery: F.O.R. Security Paper Mill Narmadapuram (Duly Unloaded).
- 2. Destination: Security Paper Mill, Narmadapuram (M.P.)-461005
- **3. Payment Terms:** 100% payment shall be done after Supply, Installation, Commissioning, Testing and Training completion by the supplier and Final Acceptance Test (suitability) of goods by the SPM, Narmadap uram and on production of all required documents by the supplier.
- **4.** Bidder Should Quote Prices Inclusive of GST And All Cost Components Such As Packing & Forwarding De tails, Freight & Insurance Charges upto Destination etc. on FOR Security Paper Mill, Narmadapuram (Madh ya Pradesh), India basis only.
- **5. Liquidated Damages (LD) Clause:** If the contractor fails to deliver the goods and/or services or any i nstallment thereof within the Delivery Period, SPM Narmadapuram shall, without prejudice to other rights a nd remedies available to SPM, Narmadapuram under the contract, deduct from the contract price, as Liqui dated damages, a sum equivalent to the rate of 0.5 Percent of the delivered price of the delayed goods an d/or services for each week of delay or part thereof until actual delivery or performance, subject to a maxi mum deduction of the 10% of the delayed goods or services.
- **6.** The terms and conditions, guidelines of SPMCIL Procurement Manual Version 3.0 will be applicable to thi s bid at any stage to avoid any conflict at later stage. - **7.** SPM (as Buyer) is liable to deduct TDS u/s 194Q @ applicable rate on goods purchases (if applicable). In case of deduction of TDS under section 194Q; the Supplier (Vendor) need not to charge TCS u/s 206C (1H) on invoicing on or after 01.07.2021.
- **8.** Vendor has to submit declaration in specified format (*refer Buyer added Specific ATC*) for the complianc e of Section 206AB of Income Tax Act, 1961. In case of non-submission of declaration; TDS will be deducte d at higher rates (as applicable) as per section 206AB.
- **9. GST Return**: Supplier should file the GST returns for outward supplies in time. SPM reserves the right to withhold the payment of further supplies till production of evidence of filling of Returns.

- **10.** Bidder shall submit duly seal & signed copy of Technical Specifications.
- **11.** No Deviation Certificate: Bidder should confirm in their quotation, "We are in acceptance of all terms a nd conditions with technical specification of Bid document without any deviation".
- **12.** Delivery period: 120 days for supply, installation & commissioning, Final Acceptation Test (FAT) and tr aining of employee of SPM as per technical specification.

13. Prequalification Criteria:

(i) Experience & Past Performance:

The bidder shall be a manufacturer that has regularly for at least the last three years manufactured, supplied, erected, commissioned a **Shredder** (for Metals like Phosphor Bronze etc.) and an **Incinerator** (for Metals like Phosphor Bronze, German Silver etc.) with the same or higher specifications of at least one number in last five years ending on 31.03.2023. At least one number of the product offered for supply should be in successful operation for at least one year on the date of bid opening.

Note: 'Startups and Micro and Small Enterprises' are exempted from 'Experience and Past Performance Criteria')

(ii) Capability-Equipment & Manufacturing Facilities:

The bidder must have an annual capacity to manufacture and supply at least 1 number each of **Shredder** (for Metals like Phosphor Bronze etc.) and an **Incinerator** (for Metals like Phosphor Bronze, German Silver etc.)

(iii) Financial Standing:

- 1) The average annual financial turnover of the bidder during the last three years, ending on 31.03.2023, s hould be at least Rs. 34,40,000 as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India or equivale nt in relevant countries.
- 2) The net worth of the firm should
- a. not be negative on 31.03.2023 and
- b. not have eroded by more than 30% in the last three years, ending on 31.03.2023.

Remark:- Bidder shall submit the Balance Sheet and Profit/Loss Statement for FY 2020-21, 21-22 and 22-23 against the financial criteria.

Note: (i) For MSEs and Start-ups (registered for the tendered item) all financial criteria shall be exempted. However, its capacity and capability may be verified (if necessary).

(ii) Start-up Enterprises: Requirements of prior experience and turnover would be relaxed for Start-up enter prises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their m eeting the quality and technical specifications. Such Start-ups may be either MSE or otherwise.

Note:

- 1. All experience, past performance and capacity/capability related data should be certified by the authori zed signatory of the bidder firm. The credentials regarding experience and past performance to the extent required as per eligibility criteria submitted by bidder may be verified from the parties for whom work has been done.
- 2. All financial standings data should be certified by Certified Accountant's e.g. Chartered Accounts (CA) in India and Certified Public Accountants/Chartered Accountants of other countries.
- 3. Bidder to furnish stipulated documents in support of fulfilment of qualifying criteria. Non-submission or i ncomplete submission of documents may lead to rejection of offer.
- 4. For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of authorised repres entative) who is a successful past supplier of 'The Product' in at least one of the recent past three procure ments, who do not meet any or more of requirements above, would also be considered to be qualified in vi ew of their proven credentials, for the maximum quantity supplied by him in such recent past.
- **14.** If required, SPM may visit the factory during techno-commercial bid stage, to ascertain the bidder man ufacturing capability.

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM.
