5. - 21.4 In the event of any rectification of a defect or replacement of any defective goods during th e warranty period, the warranty for the rectified/ replaced goods shall be extended to a further p eriod of twelve months from the date such rectified / replaced goods starts functioning to the sat isfaction of SPM.
