Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide

eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

2. Warranty

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

- **3. Payment Terms:** 100% on receipt and acceptance (suitability) of goods by t he SPM, Narmadapuram and on production of all required documents by the su pplier.
- **4.** Bidder Should Quote Prices Inclusive of GST And All Cost Components Such A s Packing & Forwarding Details, Freight & Insurance Charges upto Destination e tc. on FOR Security Paper Mill, Narmadapuram (Madhya Pradesh), India basis on ly.
- **5.** The terms and conditions, guidelines of SPMCIL Procurement Manual Version 3.0 will be applicable to this bid at any stage to avoid any conflict at later stage. Kindly refer General Instructions to Tenderer (GIT) and General Conditions of Contract (GCC) of SPMCIL Procurement Manual Version 3.0.
- **6.** SPM (as Buyer) is liable to deduct TDS u/s 194Q @ applicable rate on goods p urchases (if applicable). In case of deduction of TDS under section 194Q; the Su pplier (Vendor) need not to charge TCS u/s 206C (1H) on invoicing on or after 0 1.07.2021.
- **7.** Vendor has to submit declaration in specified format (refer Buyer added Spe cific ATC) for the compliance of Section 206AB of Income Tax Act, 1961. In case of non-submission of declaration; TDS will be deducted at higher rates (as applic able) as per section 206AB.
- **8. GST Return**: Supplier should file the GST returns for outward supplies in tim e. SPM reserves the right to withhold the payment of further supplies till produc tion of evidence of filling of Returns.
- **9.** Bidder shall submit duly seal & signed copy of Technical Specifications.

10. WARRANTY CLAUSE:

11.1 The warranty shall remain valid for twelve months after the goods have be en delivered to the final destination and accepted by SPM in terms of the contra ct or for fifteen months from the date of dispatch from the supplier's premises f or domestic goods whichever is earlier.

- 11.2 In case of any claim arising out of this warranty, SPMCIL shall promptly noti fy the same in writing to the supplier.
- 11.3 Upon receipt of such notice, the supplier shall, with all reasonable speed re place the defective goods or parts thereof, free of cost, at the ultimate destinati on. The supplier shall take over the replaced parts/ goods after providing their r eplacements and no claim, whatsoever shall lie on SPM for such replaced parts/ goods thereafter.
- 11.4 In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of SPM.
- 11.5 If the supplier, having been notified, fails to rectify/replace the defect(s) wi thin a reasonable period SPM may proceed to take such remedial action(s) as d eemed fit by SPM, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPM may have against the supplier.
- **11. Liquidated damages :** Subject to GCC clause 28, if the supplier fails to deliver any or all of the goods or fails to perform the services within the time fra me(s) incorporated in the contract, SPMCIL shall, without prejudice to other righ ts and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the $\frac{1}{2}$ % percent of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract.
