- 1. - **9.** GST Return: Supplier should file the GST returns for outward supplies in tim e. SPM reserves the right to withhold the payment of further supplies till pro duction of evidence of filling of Returns.
- **10.** Bidder shall submit duly seal & signed copy of Technical Specifications.

C. Eligibility / Qualifying Criteria

The bidder firm should meet following eligibility criteria to qualify:

- (a) For MSE/Start-up firm: Capability Equipment & Manufacturing Facilities: The bidder firm should have capability to manufacture and supply of tendered item.
- (b) For other firm Experience and past performance: The bidder firm may be M anufacturer/ Proven supplier/Authorized dealer or distributor of tendered ite m or bidder may participate with manufacturing authorization form (issued b y manufacturer of tendered item). Note: Participating bidder needs to submit all related documents along with the bid.
