1. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 6. The bidder must have capability to provide the relevant services

Financial Standing:-

1) The average annual financial turnover of the bidder during the last three years, ending on '31.03.2023', should be at least 19,45,082.08 of annual requirement or tender requirement, whichever is less 31.03.2023 as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India or equivalent in relevant countries.

2) i) The net worth of the Bidder should not be negative on 31.03.2023 and also ii) should not have eroded by more than 30% in the last three years, ending on 31.03.2023.

(viii) The employees must use the standard protection equipment intended for each job. Each piece of equipment shall be inspected before and after it is used.

Note: - Successful bidder must provide all PPE kit (Safety shoes, I-card and uniform is compulsory) necessary as per given job and follow the safety norms of factory to all employee provided in Mill Area as per the factory rules.
