**3.** The terms and conditions, guidelines of SPMCIL Procurement Manual Version 3.0 will be applicable to this bid at any stage to avoid any conflict at later stage. Kindly refer General Instructions to Tenderer (GIT) and General Conditions of Contract (GCC) of SPMCIL Procurement Manual Version 3.0 for additional terms and conditions.

**4. GST Return:** Supplier should file the GST returns for outward supplies in time. SPM reserves the right to withhold the payment of further supplies till production of evidence of filing of Returns.

**5.** Bidder shall submit duly seal & signed copy of Scope of work and undertaking.

### **6. Prequalification Criteria:**

#### **Experience & Past Performance:**

(i) The bidder (manufacturer or principal of authorised representative – hereinafter referred simply as 'The Bidder') should have supplied similar type of SERVICE of Rs 1046957.83 in any one of the last five years ending on "31.03.2023".

#### **Capability Equipment & Manufacturing Facilities:**

#### **Financial Standing:-**

**11. Installation and Commissioning:** The scope of work generally covers but not limited to Installation, Testing, Commissioning and Training at site of Installed Meter. The job is to be carried out at Security Paper Mill, Narmadapuram.

**12. Payment Terms:** 100% payment after Supply of material, Installation, Testing, Commissioning and Training at the site as per scope of work and FAT from user department, shall be made after successful production of all documents as per bid terms and condition by the firm.
