- **3. Payment Terms:** 100% payment shall be done after Supply, Installation, Commissioning, Testing and Training completion by the supplier and Final Acceptance Test (suitability) of service by the SPM, Narmada

puram and on production of all required documents by the supplier.

- **4.** Bidder Should Quote Prices Inclusive of GST And All Cost Components Such As Packing & Forwarding De tails, Freight & Insurance Charges upto Destination etc. on FOR Security Paper Mill, Narmadapuram (Madh ya Pradesh), India basis only.
- **5. Liquidated Damages (LD) Clause:** If the contractor fails to deliver the goods and/or services or any i nstallment thereof within the Delivery Period, SPM Narmadapuram shall, without prejudice to other rights a nd remedies available to SPM, Narmadapuram under the contract, deduct from the contract price, as Liqui dated damages, a sum equivalent to the rate of 0.5 Percent of the delivered price of the delayed goods an d/or services for each week of delay or part thereof until actual delivery or performance, subject to a maxi mum deduction of the 10% of the delayed goods or services.

- **7.** SPM (as Buyer) is liable to deduct TDS u/s 194Q @ applicable rate on goods purchases (if applicable). In case of deduction of TDS under section 194Q; the Supplier (Vendor) need not to charge TCS u/s 206C (1H) on invoicing on or after 01.07.2021.
- **8.** Vendor has to submit declaration in specified format (*refer Buyer added Specific ATC*) for the complianc e of Section 206AB of Income Tax Act, 1961. In case of non-submission of declaration; TDS will be deducte d at higher rates (as applicable) as per section 206AB.
- **9. GST Return**: Supplier should file the GST returns for outward supplies in time. SPM reserves the right to withhold the payment of further supplies till production of evidence of filling of Returns.
- **10.** Bidder shall submit duly seal & signed copy of Technical Specifications.
- **11.** No Deviation Certificate: Bidder should confirm in their quotation, "We are in acceptance of all terms a nd conditions with technical specification of Bid document without any deviation".
- 12. Warranty: 1. The supplier warrants that the goods supplied under the contract is new, unused, and inc orporate all re cent improvements in design and materials unless prescribed otherwise by SPMCIL in the c ontract. The su pplier further warrants that the goods supplied under the contract shall have no defect aris ing from design , materials (except when the design adopted and / or the material used are as per SPMCIL's specifications) or workmanship or from any act or omission of the supplier, that may develop under norm all use of the supplied goods under the conditions prevailing in India. 2. This warranty shall remain valid for three months after the goods or any portion thereof as the case may be, have been delivered to the final destination and installed and commissioned at the final. 4. Upon receipt of such notice, the supplier shall, with all reasonable speed (or within the period, if specified in the SCC), repair or replace the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts / goods after providing their replacements and no claim, whatsoever shall lie on SPMCIL for such replaced parts/goods thereafter.
- 5. In the event of any rectification of a defect or replacement of any defective goods during the warranty p

eriod, the warranty for the rectified/ replaced goods shall be extended to a further period of three months f rom the date such rectified / replaced goods starts functioning to the satisfaction of SPMCIL.

6. If the supplier, having been notified, fails to rectify/ replace the defect(s) within a reasonable period (or within the period, if specified in the SCC), SPMCIL may proceed to take such remedial action(s) as deemed fit by SPMCIL, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPMCIL may have against the supplier.
