#### **Buyer Added Bid Specific Additional Terms and Conditions**

- OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25
  percent at the time of issue of the contract. However, once the contract is issued, contract quantity or
  contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised
  quantity or duration
- 2. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.
- 3. Buyer Added text based ATC clauses

#### **ADDITIONAL TERMS & CONDITIONS (ATC)**

- 1. Required Terms of Delivery: F.O.R. Security Paper Mill Narmadapuram (Duly Unloaded).
- 2. Destination: Security Paper Mill, Narmadapuram (M.P.)-461005
- **3. Payment Terms:** 100% payment shall be done after service and suitability by the SPM, Narmadapura m and on production of all required documents by the supplier on monthly basis.
- **4.** Bidder Should Quote Prices Inclusive of GST And All Cost Components Such As Packing & Forwarding D etails, Freight & Insurance Charges upto Destination etc. on FOR Security Paper Mill, Narmadapuram (Mad hya Pradesh), India basis only.
- **5. Liquidated Damages (LD) Clause:** If the contractor fails to deliver the goods and/or services or any i nstallment thereof within the Delivery Period, SPM Narmadapuram shall, without prejudice to other rights and remedies available to SPM, Narmadapuram under the contract, deduct from the contract price, as Liquidated damages, a sum equivalent to the rate of 0.5 Percent of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods or services.
- **6.** The terms and conditions, guidelines of SPMCIL Procurement Manual Version 3.0 will be applicable to th is bid at any stage to avoid any conflict at later stage. n case of deduction of TDS under section 194Q; the Supplier (Vendor) need not to charge TCS u/s 206C (1 H) on invoicing on or after 01.07.2021.

- **8.** Vendor has to submit declaration in specified format *(refer Buyer added Specific ATC)* for the complianc e of Section 206AB of Income Tax Act, 1961. In case of non-submission of declaration; TDS will be deducte d at higher rates (as applicable) as per section 206AB.
- **9. GST Return**: Supplier should file the GST returns for outward supplies in time. SPM reserves the right to withhold the payment of further supplies till production of evidence of filling of Returns.
- 10. Bidder shall submit duly seal & signed copy of Technical Specifications.
- **11.** No Deviation Certificate: Bidder should confirm in their quotation, "We are in acceptance of all terms and conditions with technical specification of Bid document without any deviation".

Note: - Successful bidder must provide all PPE kit (Safety shoes, I-card, uniform and safety he lmet is compulsory) necessary as per given job and follow the safety norms of factory to all e mployee provided in Mill Area as per the factory rules.

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to

exemption provided to such sellers under GeM GTC.

- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
