- a. The material for the construction of siphon tube and CO2 gas inject tube (Inner container) shall be of copper and shall be subjected to anti-corrosive treatment.
- b. ISI marked CO2 gas cartridge of 120 gm capacity confirming to IS 4947 latest revision. The content shall be as per IS: 15222:2002.
- c. The inner and outer surface of the body shall be painted completely with epoxy polyester powder coating of shade no.539 or 538 of IS: 5 and the paint shall confirm to IS: 2932 the surface of extinguisher shall be treated with anti-corrosive before painting of the extinguisher.
- d. The discharge hose shall be PVC braided type, of minimum 450 mm length for 06 Kg.
- e. Cap assembly shall be fitted with SS made locking pin provided with SS made chain inspire of rubber with plastic mode lock guard also.
- f. Piercer shall be made of water proof type.
- g. Refill pack of Dry chemical powder shall be mono-ammonium phosphate base material of 6 Kg shall be as per IS: 4308:2019 with ISI marks and it should be provided separately in hermetically sealed moisture proof plastic bags.
- h. Wall mounting brackets & screws shall be supplied for each extinguisher.
- i. Colour of extinguisher body should be red conforming to shade no. 536 or 538 of IS 5.
- j. Marking on each extinguisher and gas cartridge should be strictly as per IS: 15683:2018.
- k. Other requirements should be as per IS 15683:2018.

3. SPARES: One extra spare filled CO2 gas cartridge of 120 gm capacity required for above extinguisher should be provided along with each extinguisher.

4. Documents: Following documents must be provided by the supplier:

- a. Acceptance test certificate.
- b. Certified BIS certification & Test report/certificate from the original manufacturer.
- c. Certificate for manufacturing from BIS
- d. Certificate for using ISI mark from BIS.
- e. Purity certificate of CO2 gas refilled in CO2 gas cartridge as per IS: 15222:2018.

5. Warranty:

- a. The DCP type fire extinguisher with its associated components shall be provided at least 1 year guarantee for their stipulated performance or any other defects.
- b. Any expense on account of repair/supply of spares against guarantee defects shall be borne by the supplier.

6. Other conditions:

- a. The tenderer should have all the testing facilities and all the expenditure of testing shall be borne by the tenderer.
- b. The tenderer shall furnish the offer by specifying the technical data. In case of deviation, the same should be clearly brought out in the offer.
- c. The tenderer shall either be the original manufacturer or authorized dealer only.
- d. Pre-dispatch Inspection shall be carried out by CISF & SPM representative at vendor's work.
