#### 1. Generic

#### 2. Certificates

#### 3. Past Project Experience

4. Liquidated Damages (LD) Clause: If the contractor fails to deliver the goods and/or services or any i

nstallment thereof within the Delivery Period, SPM Narmadapuram shall, without prejudice to other rights a nd remedies available to SPM, Narmadapuram under the contract, deduct from the contract price, as Liqui dated damages, a sum equivalent to the rate of 0.5 Percent of the delivered price of the delayed goods an d/or services for each week of delay or part thereof until actual delivery or performance, subject to a maxi mum deduction of the 10% of the delayed goods or services.

**7.** Vendor has to submit declaration in specified format *(refer Buyer added Specific ATC)* for the complianc e of Section 206AB of Income Tax Act, 1961. In case of non-submission of declaration; TDS will be deducte d at higher rates (as applicable) as per section 206AB.

**7. GST Return**: Supplier should file the GST returns for outward supplies in time. In case of any Input Cred it Loss to SPM by way of their failure to files GST Returns in time, SPM reserves the right to withhold the pa yment of further supplies till production of evidence of filling of Returns.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
