- 1. Part Quantity Bidding

Buyer has allowed part quantity bidding, bidders can offer maximum quantity that they can deliver keeping in mind their capacity and delivery period requirements. The offer quantity has to be more than minimum bid quantity as specified by the Buyer in the bid. Offers with quantity less than Minimum are liable to be rejected. It may however be noted that there is no guarantee that full offer quantity will be ordered by the buyer. - 2. **Payment Terms:** 100% on receipt and acceptance (suitability) of goods by the SPM, Narmadapuram and on production of all required documents by the supplier.

4. PARALLEL CONTRACTS:

- a. The Chief General Manager, Security Paper Mill, Narmadapuram reserves the right to conclude parallel contracts, with more than one bidder for this tender.
- b. The bidders should quote for at least 25% of the tendered quantity in this tend er. Offers that are received for less than 25% shall be considered as unresponsi ve and shall be rejected and the accepted firms shall be ranked as L1, L2, L3, et c in the ascending order as per the rate quoted in the Price Bid.
- c. Splitting may be done among maximum Three (03) Bidders in the ratio of 70:3 0 or 50:30:20 of the total bid quantity.
- d. The following guidelines are to be considered while opting for parallel contract s:
 - i) L1 should be awarded at least the percentage mentioned above or his spare supply capacity, whichever is lower; and
 - ii) For the rest of the contract quantity, the lowest rate accepted will be counter offered to the L2 party. On acceptance of the counter offer, the order will be pla ced on L2 for the respective percentage or the spare supply capacity of the L2 b idder, whichever is lower, and so on, to other tenderers. - 8. **Liquidated Damages (LD) Clause:** If the contractor fails to deliver the goods a nd/or services or any installment thereof within the Delivery Period, SPM Narmada puram shall, without prejudice to other rights and remedies available to SPM, Narmadapuram under the contract, deduct from the contract price, as Liquidated damages, a sum equivalent to the rate of 0.5 Percent of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods or services.

- 11. Vendor has to submit declaration in specified format for the compliance of Sectio n 206AB of Income Tax Act, 1961. In case of non-submission of declaration; TDS w ill be deducted at higher rates (as applicable) as per section 206AB.
- 12. GST Return: Supplier should file the GST returns for outward supplies in time. SP M reserves the right to withhold the payment of further supplies till production of evidence of filling of Returns.

13. Manufacturer Authorization Certificate:

Note:-

a) The allowable periodic variation would be +/- 5%. Under no circumstances, ma terials will be accepted beyond (+)5% allowed quantity tolerance. Any variation in periodic rate of supply more than (-)5% in each delivery schedule would be c onsidered as delay in delivery. LD will be imposed on such short supplies beyon d (-)5% for each delivery.

This is without prejudice to Force Majeure Clause. In any circumstances, the total Purchase Order qty. will not be exceeded.

16. WARRANTY CLAUSE:

- 21.1 The warranty shall remain valid for Twelve months after the goods h ave been delivered to the final destination and accepted by SPM in terms of the contract or for fifteen months from the date of dispatch from the su pplier's premises for domestic goods whichever is earlier.
- 21.2 In case of any claim arising out of this warranty, SPMCIL shall prompt ly notify the same in writing to the supplier.

- 21.3 Upon receipt of such notice, the supplier shall, with all reasonable sp eed replace the defective goods or parts thereof, free of cost, at the ultim ate destination. The supplier shall take over the replaced parts/ goods aft er providing their replacements and no claim, whatsoever shall lie on SPM for such replaced parts/ goods thereafter.
- 21.4 In the event of any rectification of a defect or replacement of any def ective goods during the warranty period, the warranty for the rectified/ re placed goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of SPM.
- 21.5 If the supplier, having been notified, fails to rectify/replace the defect (s) within a reasonable period SPM may proceed to take such remedial act ion(s) as deemed fit by SPM, at the risk and expense of the supplier and w ithout prejudice to other contractual rights and remedies, which SPM may have against the supplier.

17. SHORT CLOSE/ TERMINATION OF CONTRACT:

The Chief General Manager, Security Paper Mill, Narmadapuram, reserve the right at any stage by giving one week's notice without assigning the reason:-

- (i) To short close or terminate the order at any time during process of supply a gainst our supply order.
- (ii) To reduce the tender quantity at the time of concluding the final supply ord er.

18. Resolution of Disputes:

If dispute or difference of any kind shall arise between SPM, Narmadapuram and the supplier in connection with or relating the contract, the parties shall make every effort to resolve the same amicably by mutual consultations. If the parties fail to resolve their dispute or difference by such mutual consultation within 21 days of it soccurrence, then, unless otherwise provided in the SCC, either SPM, Narmadapuram or the supplier may seek recourse to settlement of disputes through arbitration act 33.2.

19. Quality Control Requirements

- i. The firm must indicate in their techno-commercial bid whether they are m anufacturer or a dealer/trader of the item offered by them.
- ii. The firm must give an undertaking in their techno-commercial bid that the product offered by them conforms to the above specifications.
- iii. The bidder has to provide technical leaflet of the product offered by them containing the specifications along with the techno-commercial bid.
- iv. MSDS: Copy of Material Safety Data Sheet should be sent by bidder along with the every dispatch documents of supplies. Material Safety Data Sheet s hould be as per ISO guidelines or in the format prescribed in Factories Act,1 948.

- v. Material shall be tested in SPM QC lab & decision of SPM QC lab shall be final & binding on the contract.
- vi. Certificate of chemical analysis from the manufacturer must accompany with each supply.
- vii. Sample: Not required.
- viii. The material must be free from any contamination like dirt, foreign particle, sand etc.
