**3.** Bidder Should Quote Prices Inclusive of GST And All Cost Components Such As Packing & Forwarding De tails, Freight & Insurance Charges up to Destination etc. on FOR Security Paper Mill, Narmadapuram (Madh ya Pradesh), India basis only.

**4.
