- 1. - 3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order

quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

#### **Scope of Work**

Specification of work:

Deep cleaning and scale removal work from outer surface of drier cylinder in pa per machine. After removal of scale buffing work should be done by buffing tool

- 1. Buffing should be performed by nonmetallic (fiber glass or carbon fiber or Tef lon, nylon or polythene)
- 2. The chemical should be non-acidic or the material should not eroded from parent material and should not corroded the dryer.

Dimension of cylinder:

Diameter of a drier cylinder-1380mm (4.5ft)

Length of drier cylinder – 2400mm

Scope of work:

- 1. Drier cylinder deep cleaning and buffing work should be done thoroughly without removing from machine. If any parts removed from the machine firm has to refit the same after completion of work.
- 2. During the job work process all safety measures should be taken by the firm.
- 3. Safety PPE has to be brought by the firm only.

- 4. All required tools and accessories required to complete the job has to brough t by the firm.
- 5. Sufficient man power has to be deployed by the firm to complete the job wor k.
- 6. Work has to be completed within 8 days in each machine from starting date.
- 7. Firm should visit SPM for better understanding.
- 8. Air, water, power will be supplied by SPM, but extension cord for power supply and Flexible air pipe should be provided by the farm.
- 9. Work should be done without any damage of parts and screen.
- 10. After completion of work surrounding the area should be cleaned by the far m

- **5. Liquidated Damages (LD) Clause:** If the contractor fails to deliver the go ods and/or services or any installment thereof within the Delivery Period, SP M Narmadapuram shall, without prejudice to other rights and remedies avail able to SPM, Narmadapuram under the contract, deduct from the contract price, as Liquidated damages, a sum equivalent to the rate of 0.5 Percent of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods or services.
- **6.** The terms and conditions, guidelines of SPMCIL Procurement Manual Versio n 3.0 will be applicable to this bid at any stage to avoid any conflict at later s tage.

- **9.** Vendor has to submit declaration in specified format (refer Buyer added Sp ecific ATC) for the compliance of Section 206AB of Income Tax Act, 1961. In case of non-submission of declaration; TDS will be deducted at higher rates ( as applicable) as per section 206AB.
- **10.** GST Return: Supplier should file the GST returns for outward supplies in tim e. SPM reserves the right to withhold the payment of further supplies till production of evidence of filling of Returns.
- **11.** Bidder shall submit duly sealed & signed copy of Technical Specifications.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
