14. WARRANTY CLAUSE:

14.1 The warranty shall remain valid for Twelve months after the goods have been delivere d to the final destination and accepted by SPM in terms of the contract or for fifteen month s from the date of dispatch from the supplier's premises for domestic goods whichever is e arlier.

14.2 In case of any claim arising out of this warranty, SPMCIL shall promptly notify the sam e in writing to the supplier.

14.3 Upon receipt of such notice, the supplier shall, with all reasonable speed replace the d efective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall t ake over the replaced parts/ goods after providing their replacements and no claim, whatso ever shall lie on SPM for such replaced parts/ goods thereafter.

14.4 In the event of any rectification of a defect or replacement of any defective goods duri ng the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts funct ioning to the satisfaction of SPM.

14.5 If the supplier, having been notified, fails to rectify/replace the defect(s) within a reas onable period SPM may proceed to take such remedial action(s) as deemed fit by SPM, at t he risk and expense of the supplier and without prejudice to other contractual rights and re medies, which SPM may have against the supplier.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
