# **1. Required Terms of Delivery:**

- 2. **Payment Terms:** 100% on receipt and acceptance (suitability) of goods by the SPM, Narmadapuram with election and commissioning of material and on producti on of all required documents by the supplier.
- 3. Bidder Should Quote Prices Inclusive of GST And All Cost Components such as Pa

# 13. Scope of Work

4. The vendor shall be responsible to replace old switches in the existing net work with the new switches.

ments specified by SPM Narmadapuram and ensure integration with existing network infrastructure.

6. The vendor shall conduct comprehensive testing to ensure the proper func tioning of the switches and their compatibility with the existing network.

8. Onsite support services, including troubleshooting assistance and firmwar e updates, etc. shall be provided by the vendor for the duration of the warra nty period.

9. The OEM must have a service center located in Madhya Pradesh.

# 15. Warranty Clause:

21.1 The warranty shall remain valid for 5 (Five) years after the goods hav e been delivered to the final destination and accepted by SPM in terms of the contract.

21.2 In case of any claim arising out of this warranty, SPMCIL shall prompt ly notify the same in writing to the supplier.

21.3 Upon receipt of such notice, the supplier shall, with all reasonable sp eed replace the defective goods or parts thereof, free of cost, at the ultim ate destination. The supplier shall take over the replaced parts/ goods aft er providing their replacements and no claim, whatsoever shall lie on SPM for such replaced parts/ goods thereafter.

21.4 In the event of any rectification of a defect or replacement of any def ective goods during the warranty period, the warranty for the rectified/ re placed goods shall be extended to a further period of 5 (Five) years from t he date such rectified / replaced goods starts functioning to the satisfactio n of SPM.
