1. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Part Quantity Bidding

Buyer has allowed part quantity bidding, bidders can offer maximum quantity that they can deliver keeping in mind their capacity and delivery period requirements. The offer quantity has to be more than minimum bid quantity as specified by the Buyer in the bid. Offers with quantity less than Minimum are liable to be rejected. It may however be noted that there is no guarantee that full offer quantity will be ordered by the buyer. Quantity to be ordered by the buyer will depend on various factors including the Ranking of the bidder, Offered quantity, Splitting criteria indicated by the buyer in the bid and the requirement of the buyer to have multiple sources of supply for ensuring supply chain etc. Sellers would be notified about likely order quantity or range of possible order quantity at the time of price match request made by the buyer. ward of contract will be subject to acceptance of price match request along with min / max offer quantity as decided by the Buyer.

4. PARALLEL CONTRACTS :

After deciding the acceptable reasonable price, L1 would be awarded contract for at least the first/ highest percentage indicated in the bid splitting ratio. - i. The firm must give an undertaking in their Techno-Commercial bid that the product offered by them conforms to the technical specifications given in NIT.
- ii. MSDS: Copy of Material Safety Data Sheet should be sent by bidder along with the every dispatch documents of supplies. Material Safety Data Sheet should be as per ISO guidelines or in the format prescribed in Factories Act, 1948.
- iii. Material shall be tested in SPM QC lab & decision of SPM QC shall be final & binding on the contract.
- iv. Certificate of chemical analysis (COA) from the manufacturer must accompany with each supply along with all the technical specification as given in NIT.
- v. Sample: Not required.
- vi. The Material must be free from any contamination like dirt, foreign particles, sand etc.
- vii. The packing shall bear legibly the following information: a) Name & Grade of the material; b) Name of the manufacturer and his recognized trade-mark, if any; c) Weight in Kg.

15. Delivery Schedule:

The contract shall remain valid for the period of one year from the date of issue of GeM contract and Material shall be taken in staggered manner.

- i. First Supply of **40 MT** within 30 days from the date of issue of GeM contract.
- ii. For Remaining supplies, SPM shall intimate the supply quantity and date of delivery/ies minimum 30 days in advance through E-mail/letter.

Note:-

- a) The allowable periodic variation would be +/- 5%. Under no circumstances, materials will be accepted beyond (+)5% allowed quantity tolerance. Any variation in periodic rate of supply more than (-)5% in each delivery schedule would be considered as delay in delivery. LD will be imposed on such short supplies beyond (-)5% for each delivery.
This is without prejudice to Force Majeure Clause. In any circumstances, the total Purchase Order quantity will not be exceeded.
- b) The above delivery schedule may vary as per our requirement.
- c) The above mentioned quantity may be divided proportionately in case of parallel contract.

16. WARRANTY CLAUSE:

17.1 The warranty shall remain valid for Three months after the goods have been delivered to the final destination and accepted by SPM in terms of the contract or for fifteen months from the date of dispatch from the supplier's premises for domestic goods whichever is earlier.

17.2 In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.

17.3 Upon receipt of such notice, the supplier shall, with all reasonable speed replace the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, whatsoever shall lie on SPM for or such replaced parts/ goods thereafter.

17.4 In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of Three months from the date such rectified / replaced goods starts functioning to the satisfaction of SPM.

17.5 If the supplier, having been notified, fails to rectify/replace the defect(s) within a reasonable period SPM may proceed to take such remedial action(s) as deemed fit by SPM, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPM may have against the supplier.

17. SHORT CLOSE/ TERMINATION OF CONTRACT:

The Chief General Manager, Security Paper Mill, Narmadapuram, reserve the right at any stage by giving one week's notice without assigning the reason:-

- (i) To short close or terminate the order at any time during process of supply against our supply order.
- (ii) To reduce the tender quantity at the time of concluding the final supply order.

18. Resolution of Disputes:

If dispute or difference of any kind shall arise between SPM, Narmadapuram and the supplier in connection with or relating the contract, the parties shall make every effort to resolve the same amicably by mutual consultations. If the parties fail to resolve their dispute or difference by such mutual consultation within 21 days of its occurrence, then, unless otherwise provided in the SCC, either SPM, Narmadapuram or the supplier may seek recourse to settlement of disputes through arbitration act 33.2.

19. Bidder has to submit duly seal & signed of Complete GEM Bid, Technical Specification Capacity and capability assessment form (with complete proper data) and Declaration of Annexure I, II, III, Manufacture's authorization Form & Capability & capacity assessment form (Attached in ATC).
