- 1. Application:** Dilution of higher consistency cotton pulp with dosing of 98% Sulphuric Acid ( $H_2SO_4$ ) in dilution tank to maintain pH of the Pulp.
- 2. Existing facility:** RCC tank with tile lining all the inside planes of tank.
- 3. Work:** Fabrication of Dilution Tank on Turnkey basis:-  
Fabrication & Installation of SS lining MOC 904 L inside existing Dilution tank of concrete (RCC) Tank on Turnkey basis.
- 4. Dimensions of existing RCC tank**
  1. Dilution Tank Design capacity of Tank -7.5 m<sup>3</sup>
  2. Dilution Tank Size: (LXWXH) 80" X 80" X 65" (Inside Tanks Approx.)
  3. Storage Medium: Pulp
  4. Quantity : One (01)
  5. Type : Square shape
  6. Surface: Inside Tile lining in all 6 planes.
- 5. Details of the fabrication work**
  1. MOC: Tank Material of Construction should be as follows
    - a) Shell: SS904L with 8 mm Thickness.
    - b) Suction Nozzle: All existing S.S nozzle opening should be maintain with insert plate of SS904L
  2. Welding Electrode - Welding MIG wire-SS 904 L
  3. Construction of Tank by MIG/Argon Welding
  4. S.S.Plates should be bend accurately and cut by laser cutting to maintain profile of the existing tank
  5. Tank design should be maintain as zero liquidity.
  6. Testing of Welding Joints: On site 100% DPT & 10% Radiography/ultrasonic test and certificate to be provided by the supplier
  7. Welding fabrication work will be carried out inside the existing tank only as retrofitting.
  8. Successful bidder shall visit SPM, Narmadapuram to understand the requirement and difficulties because working area is very confined space. Size- (LXW) 1040 X 530 mm
  9. Remove all Sharp edges of tank by grinding/ buffing.
  10. Welding should be free from pin holes, blow hole, also stress should be relieved from all the surfaces & corners.
  11. Firm should completely covered tank all side and maintain all suction, discharge, drain, overflow, and LT, nozzle etc.
  12. All types of Tools, tackles, Lights inside the tank, consumable welding wire/electrode, welding machine, industrial gas and cutting wheel and other consumable items and facilities will be in scope of supplier.
  13. Firm should ensure about all fitment and size as identical retrofitting of S.S. lining in existing tank without any deviation in process parameter like drain slope and all the opening must be maintained as existing.
  14. The data given in specification is for reference purpose only to understand requirement, explore detailed scope of work and take final dimensions of the Dilution Tank. Firm will prepare drawings & work plan and share with SPM to cross check the dimension before starting of manufacturing work.

- a. Three similar completed works each costing not less than the amount equal to Rs. 17.27 Lakhs or
- b. Two similar completed works each costing not less than the amount equal to Rs. 21.59 Lakhs or
- c. One similar completed work costing not less than the amount equal to Rs. 34.55 Lakhs.

**2. Capability:** Equipment & Manufacturing Facilities: The bidder should be enlisted in either Central Public Works Department (CPWD) or Military Engineering Services (MES) or any other Government / PSU / Autonomous bodies.

**3.
