- **1. Application:** Dilution of higher consistency cotton pulp with dosing of 98% Sulphuric Acid (H<sub>2</sub>SO<sub>4</sub>) in dilution tank to maintain pH of the Pulp.
- 2. Existing facility: RCC tank with tile lining all the inside planes of tank.
- Work: Fabrication of Dilution Tank on Trunkey basis:-Fabrication & Installation of SS lining MOC 904 L inside existing Dilution tank of concrete (RCC) Tan k on Trunkey basis.

**2. Capability:** Equipment & Manufacturing Facilities: The bidder should be enlisted in either Central Publi c Works Department (CPWD) or Military Engineering Services (MES) or any other Government / PSU / Auto nomous bodies.

**3. Financial Standing:** The average annual financial turnover of the bidder during the last three years, e nding on '31.03.2024', should be at least Rs. 17.27 Lakhs as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Acco untant in India.
