Coverage:

- a) During the period of AMC, Service Engineers will visit the specified unit two times per annum for carrying out ntive maintenance of the machines. Of these one will be for overhauling and preparation of machines for re-version by Government inspectors in accordance with Weights and Measures Act.
- b) Firm will attend to all breakdown calls as and when required.

- 4. Electrical supply line to the instrumentation should not be connected to any other equipment such as air con ers, crushers, and motors or any other heavy fluctuating loads.
