- c) The Service Provider shall not interfere or disturb electric fuses, wiring and othe r electrical equipment belonging to the Buyer or other Contractors under any circums tances, whatsoever, unless expressly permitted in writing by Buyer to handle such fuses, wiring or electrical equipment.
- d) No electric cable in use by the Buyer will be disturbed without prior permission. No weight of any description will be imposed on any cable and no ladder or similar equipment will rest against or attached to it.
- e) It is mandatory for the Service Provider to observe during the execution of the w orks, requirements of Safety Rules which would generally include but not limited to f ollowing:

#### **Safety Rules**

- (i) Each employee shall be provided with initial indoctrination regarding safety by the Service Provider, so as to enable him to conduct his work in a safe manner.
- (ii) No employee shall be given a new assignment of work unfamiliar to him witho ut proper introduction as to the hazards incident thereto, both to himself and his fello w employees.
- (iii) Under no circumstances shall an employee hurry or take unnecessary chance w hen working under hazardous conditions.
- (iv) Employees must not leave naked fires unattended. Smoking shall not be permit ted around fire prone areas.
- (v) Employees under the influence of any intoxicating beverage, even to the sligh test degree shall not be permitted to remain at work.
- (vi) The employees when working around moving machinery must not be permitte d to wear loose garments.
- (vii) Safety shoes are recommended when working in shops or places where materia Is or tools are likely to fall. Only experienced workers shall be permitted to go behind guard rails or to clean around energized or moving equipment.
- (viii) The employees must use the standard protection equipment intended for each j ob. Each piece of equipment shall be inspected before and after it is used.

Note: - Successful bidder must provide all PPE kit (Safety shoes, I-card, unif orm and safety helmet is compulsory) necessary as per given job and follow the safety norms of factory to all employee provided in Mill Area as per the factory rules.

Note:- Firm has to submit the addition performance security after amendment of contract und er minimum wages.

#### Liquidated damages

If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s ) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SP MCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the  $\frac{1}{2}$ % percent of the delivered price of the delayed goods and/ or services for each week of delay or part there of until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
