1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Part Quantity Bidding

Buyer has allowed part quantity bidding, bidders can offer maximum quantity that they can deliver keeping in mind their capacity and delivery period requirements. The offer quantity has to be more than minimum bid quantity as specified by the Buyer in the bid. Offers with quantity less than Minimum are liable to be rejected. It may however be noted that there is no guarantee that full offer quantity will be ordered by the buyer. 15. Delivery Schedule:

- (ii) 10 MT to be delivered within 30 days from the date of GeM contract/NAC/PO whichever is earlier.
- (iii) Material shall be taken in staggered manner.
- (iv) For remaining supplies SPM shall intimate the supply quantity and date of delivery/ies minimum 30 days i n advance through E-mail/letter.

(i) The allowable periodic variation would be +/- 5%. Under no circumstances, materials will be accepted b eyond (+) 5% allowed quantity tolerance. This is without prejudice to Force Majeure Clause. In any circumstances, the total Purchase Order q ty. will not be exceeded.

(ii) The above delivery schedule may be vary as per our requirement.

(iii) The above mentioned quantity may be divided proportionately in case of parallel contract.

16. WARRANTY CLAUSE:

21.1 The warranty shall remain valid for Twelve months from the date of last supply to the final de stination and accepted by SPM in terms of the contract or for fifteen months from the date of dispa tch from the supplier's premises for domestic goods whichever is earlier.

21.2 In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writ ing to the supplier.

21.3 Upon receipt of such notice, the supplier shall, with all reasonable speed replace the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the re placed parts/ goods after providing their replacements and no claim, whatsoever shall lie on SPM f or such replaced parts/ goods thereafter.

21.4 In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further perio d of Twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of SPM.

21.5 If the supplier, having been notified, fails to rectify/replace the defect(s) within a reasonable p eriod SPM may proceed to take such remedial action(s) as deemed fit by SPM, at the risk and expe nse of the supplier and without prejudice to other contractual rights and remedies, which SPM may have against the supplier.

17. SHORT CLOSE/ TERMINATION OF CONTRACT:

The Chief General Manager, Security Paper Mill, Narmadapuram, reserve the right at any stage by giving o ne week's notice without assigning the reason:-

(i) To short close or terminate the order at any time during process of supply against our supply order.

(ii) To reduce the tender quantity at the time of concluding the final supply order.

18. Quality Control Requirements
