- **13.2** In case of any claim arising out of this warranty, SPMCIL shall promptly noti fy the same in writing to the supplier.
- **13.3** Upon receipt of such notice, the supplier shall, with all reasonable speed re place the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods after providin g their replacements and no claim, whatsoever shall lie on SPM for such replace d parts/ goods thereafter.
- **13.4** In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of SPM.
- **13.5** If the supplier, having been notified, fails to rectify/replace the defect(s) within a reasonable period SPM may proceed to take such remedial action(s) as deemed fit by SPM, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPM may have against the supplier.

Note: All the supplies must be mentioned with Expiry date.

14. SHORT CLOSE/ TERMINATION OF CONTRACT:

The Chief General Manager, Security Paper Mill, Narmadapuram, reserve the right at any stage by giving one week's notice without assigning the reason:-

- (i) To short close or terminate the order at any time during process of supply ag ainst our supply order.
- (ii) To reduce the tender quantity at the time of concluding the final supply order

15. Resolution of Disputes:

If dispute or difference of any kind shall arise between SPM, Narmadapuram and the supplier in connection with or relating the contract, the parties shall make e very effort to resolve the same amicably by mutual consultations. If the parties f ail to resolve their dispute or difference by such mutual consultation within 21 d ays of its occurrence, then, unless otherwise provided in the SCC, either SPM, N armadapuram or the supplier may seek recourse to settlement of disputes through arbitration act 33.2.

16. Option Clause:

The Purchaser reserves the right to increase/decrease the ordered quantity by u p to 25% at any time, till final delivery date of the contract (or the extended delivery date of the contract), by giving reasonable notice even though the quantity ordered initially has been supplied in full before the last date of Delivery Period (or the extended delivery period of the contract).
