- 1. The supplier shall take over the replaced parts/ goods after providing their r eplacements and no claim, whatsoever shall lie on SPM for such replaced parts/ goods thereafter.
- **13.4** In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of SPM.
- **13.5** If the supplier, having been notified, fails to rectify/replace the defect(s) wi thin a reasonable period SPM may proceed to take such remedial action(s) as d eemed fit by SPM, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPM may have against the supplier.

Note: All the supplies must be mentioned with Expiry date.

14. SHORT CLOSE/ TERMINATION OF CONTRACT:

The Chief General Manager, Security Paper Mill, Narmadapuram, reserve the right at any stage by giving one week's notice without assigning the reason:-

- (i) To short close or terminate the order at any time during process of supply a gainst our supply order.
- (ii) To reduce the tender quantity at the time of concluding the final supply orde r.

15. Resolution of Disputes:

If dispute or difference of any kind shall arise between SPM, Narmadapuram and the supplier in connection with or relating the contract, the parties shall make e very effort to resolve the same amicably by mutual consultations. If the parties fail to resolve their dispute or difference by such mutual consultation within 21 days of its occurrence, then, unless otherwise provided in the SCC, either SPM, Narmadapuram or the supplier may seek recourse to settlement of disputes thr ough arbitration act 33.2.
