# 12. Prequalification Criteria:

# (i) Experience & Past Performance:

The bidder (manufacturer or principal of authorised representative- hereinafter re ferred simply as 'The Bidder') should have manufactured and supplied "RO Electr ode Plates" of at least "400 pieces" in any one of the last five years ending on 31 st March 2024.

# (ii) Capability Equipment & Manufacturing Facilities:

The bidder must have an annual capacity to manufacture and supply at least 400 pieces of RO Electrode Plates.

# (iii) Financial Standing:

- 1) The average annual financial turnover of the bidder during the last three years, ending on 31.03.2024, should be at least Rs. 14,33,464 as per the annual report ( audited balance sheet and profit & loss account) of the relevant period, duly auth enticated by a Chartered Accountant/Cost Accountant in India or equivalent in rel evant countries.
- 2) The net worth of the firm should:

## 13. WARRANTY CLAUSE:

- 13.1 The warranty shall remain valid for Twelve months after the goods have bee n delivered to the final destination and accepted by SPM in terms of the contract or for fifteen months from the date of dispatch from the supplier's premises for do mestic goods whichever is earlier.

- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
