- **5. 13. WARRANTY CLAUSE:

- 13.1 The warranty shall remain valid for **Three Years (3 Years)** after the goods have been delivered to t he final destination and accepted by SPM in terms of the contract or for fifteen months from the date of dis patch from the supplier's premises for domestic goods whichever is earlier.
- 13.2 In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.
- 13.3 Upon receipt of such notice, the supplier shall, with all reasonable speed replace the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, whatsoever shall lie on SPM for such replaced parts/ goods thereafter.

13.4 In the event of any rectification of a defect or replacement of any defective goods during the warrant y period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve mon the from the date such rectified / replaced goods starts functioning to the satisfaction of SPM.

13.5 If the supplier, having been notified, fails to rectify/replace the defect(s) within a reasonable period S PM may proceed to take such remedial action(s) as deemed fit by SPM, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPM may have against the supplier.

14. SHORT CLOSE/ TERMINATION OF CONTRACT:

If dispute or difference of any kind shall arise between SPM, Narmadapuram and the supplier in connection with or relating the contract, the parties shall make every effort to resolve the same amicably by mutual c onsultations. If the parties fail to resolve their dispute or difference by such mutual consultation within 21 days of its occurrence, then, unless otherwise provided in the SCC, either SPM, Narmadapuram or the supp lier may seek recourse to settlement of disputes through arbitration act 33.2.
