Design, Construction, Erection, Commissioning & Testing of Intake Well Capacity of 15 MLD, Laying of water pipe line from Narmada River bank to SPM plant Narmadapuram, on Turnkey basis.

Security Paper Mill (SPM, Narmadapuram) is a unit of SPMCIL a Mini-Ratna Category – I CPSE and a wholly owned schedule 'A' Company of Government of India and is under the administrative control of Department of Economic Affairs, Ministry of Finance, Government of India. It is engaged in sovereign function, production of Currency paper/ Security paper.

Security Paper Mill, Narmadapuram is an ISO 9001:2015,ISO 14001:2015, ISO 45001: 2018 & ISO 50001:2018 certified unit. Also unit is NABL ISO/IEC 17025:2017 certified.

Security Paper Mill (SPM), Narmadapuram, intends to develop an **intake well of capacity 15 MLD** on the bank of the Narmada River to meet its industrial water requirements. The project involves the Planning, Design, Construction of INTAKE WELL, Pump house Commissioning Laying of Pipe line to SPM Plant on turnkey basis.

Execution of a modern intake well system to ensure sustainable and reliable water supply.

Through this EOI, eligible and experienced agencies/contractors are invited to submit their credentials for the proposed work.

#### **Scope of Work:**

The following scope of work for construction of new intake well for supply of 15 MLD of water :-

- 1. Design and Construction of RCC intake well for 15MLD water supply from Narmada River bank in Narmadapuram and pump house, electrical Power substation i.e. Civil, Electrical, Mechanical etc. including allied works.
- 2. Providing and laying of pipe line & pumping from intake well to existing water treatment plant in SPM.
- 3. Obtaining all clearance/NOC from the various stakeholders of Government Departments. However official fees any will be paid by SPMN.
- 4. Miscellaneous works related to INTAKE WELL Project on Turnkey basis.
- 5. Study of location of Intake well at Narmada river bank considering the availability of water throughout the year.
- 6. Bidder should submit the project synopsis in detail specifications along with cost estimation of the project on turnkey basis.
- 7. Operation and maintenance work of 5 years after 3 months of trial run period. There shall be 24 months defect free liability period which will be within 5 year 0&M period.
- 8. Firm shall give presentation at Security Paper Mill, Narmadapuram for the EOI title.

### Eligibility and Pre-Qualification Criteria:

- **Financial Capability:** Demonstrating a minimum financial turnover or sufficient liquid assets and credit facilities.
- **Technical Expertise:** Possessing adequate design, infrastructure, and erection facilities, as well as the necessary licenses and certifications.

- **Experience:** Evidence of successful completion of similar projects within a specified timeframe, often requiring completion certificates and work orders as proof.
- Reputation: Firm should not be ban /blacklisted, holiday listed with any PSU, GOVT, Autonomous body.

#### **Submission Requirements:**

- **Completeness:** Bidders must submit a full and complete response, including all information requested in the EOI documents.
- **Documentation:** Providing all required forms, statements, and attachments, such as those for personnel, financial information, and technical solutions.

The Expression of Interest must be submitted with the brief profile of the firm, their past performance in similar field of INTAKE WELL DESIGN, ERECTION & COMMISSIONING, LAYING OF PIPE LINE, financial background etc. in support of the eligibility criteria.
