The Instrument must comply with latest CPCB/MPPCB norms wrt RTEQ MS released (if any) during warranty and AMC period.

- **11.** Travel, lodging and boarding shall be in the scope of the bidder for the delivery of tendered item and AMC & Calibration for 3 years after the warrantee.
- **12.** Bidder shall submit duly seal & signed copy of Technical Specifications, GeM bid document.

13. Prequalification Criteria:

(i) Experience & Past Performance:

The bidder (manufacturer or principal of authorised representative- hereinafter referred simply as 'The Bidder') shall be a manufacturer that has regularly for a t least the last three years manufactured, supplied, erected, commissioned 'RTE QMS Instrument' with the same or higher specifications of at least one number in last five years ending on 31st March 2025. At least one number of the product offered for supply should be in successful operation for at least one year on the date of bid opening.

(ii) Capability Equipment & Manufacturing Facilities:

The bidder must have an annual capacity to manufacture and supply at least 1 number of 'RTEQMS Instrument'.

(iii) Financial Standing:

- 1) The average annual financial turnover of the bidder during the last three years, ending on 31.03.2025, should be at least Rs. 14,17,416 as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India or equivalent in relevant countries.
- 2) The net worth of the firm should:
- a. not be negative on '31.03.2025' and also
- b. not have eroded by more than 30% in the last three years, ending on '31.03. 2025'.

Note: For MSEs and Start-ups (registered for the tendered item) all financial crit eria shall be exempted. However, its capacity and capability may be verified (if necessary).

14. WARRANTY CLAUSE:

- 14.1 The warranty shall remain valid for Twelve months after the goods have be en delivered to the final destination and accepted by SPM in terms of the contra ct or for fifteen months from the date of dispatch from the supplier's premises f or domestic goods whichever is earlier.
- 14.2 In case of any claim arising out of this warranty, SPMCIL shall promptly noti fy the same in writing to the supplier.
- 14.3 Upon receipt of such notice, the supplier shall, with all reasonable speed re place the defective goods or parts thereof, free of cost, at the ultimate destinati on. The supplier shall take over the replaced parts/ goods after providing their r eplacements and no claim, whatsoever shall lie on SPM for such replaced parts/ goods thereafter.
- 14.4 In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of SPM.
- 14.5 If the supplier, having been notified, fails to rectify/replace the defect(s) wi

thin a reasonable period SPM may proceed to take such remedial action(s) as d eemed fit by SPM, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPM may have against the supplier.

15. SHORT CLOSE/ TERMINATION OF CONTRACT:

The Chief General Manager, Security Paper Mill, Narmadapuram, reserve the right at any stage by giving one week's notice without assigning the reason:-

(i) To short close or terminate the order at any time during process of supply a gainst our supply order.

16. Resolution of Disputes:

If dispute or difference of any kind shall arise between SPM, Narmadapuram and the supplier in connection with or relating the contract, the parties shall make e very effort to resolve the same amicably by mutual consultations. If the parties fail to resolve their dispute or difference by such mutual consultation within 21 days of its occurrence, then, unless otherwise provided in the SCC, either SPM, Narmadapuram or the supplier may seek recourse to settlement of disputes thr ough arbitration act 33.2.
