**5. ## **Scope of Work for Hiring of Services for Shifting, Packing & Loading of Boxes/Webs:**

### **Quantity**

Sr.No.	Service Description	Qty	UoM
1	Packing and Shifting of Boxes/Webs	21,000	Nos
2	Loading of Boxes/Webs	21,000	Nos

1. Shifting of 70-80 nos. of wooden pallets per day (approximate weight of 1 wooden pallet shall be 12-15 kg) with help of manually operated trolley which can carry maximum 15 nos. of wooden pallets once, from plywood stacking area (ground floor) to ream line stacking area (first floor) of finishing house via lift/stairs.

2. Unloading of all reams weighing approx. 22-25 Kgs each from ream line conveyor in all 3 shifts (A/B/C) in stack form of 15/20 reams. After every 15/20 reams stack; at ream line conveyor, an edge protector has to be applied on every corner of the stack of 15 reams and then send for wrapping machine.

3. Shifting of approximately 80-90 nos. reams stack (15 reams) along with wooden pallet one by one from ream line area (first floor) to strong room (ground floor) via lift with help of manual/hydraulic pallet truck. Similarly webs (circular) of Security Paper weighing around 300-350KG to be shifted from ream line area (first floor) to strong room (ground floor) via lift.
4. Shifting stack of 15/20 reams of finished paper which is properly wrapped in shrink film on wooden pallet, approximate weight shall be max. 400 kg each from ream line area (sheeter end point) to designated area on same floor with the help of electric/manual pallet truck. This work has to be carried out in A, B & C shifts respectively.
5. Shifting of collapsible wooden box sides and top cover from plywood stacking area (ground floor) to strong room (ground floor).
6. Packing of stack in to the collapsible plywood box and strap it with strapping tape with help of strapping tools. One plywood box size shall be approximately 1 meter × 1 meter × 1 meter and approximate weight of plywood box shall be 400kg after packing.
7. Proper stacking of packed plywood boxes one above the other and again strapping with the strapping tape.
8. Loading of plywood boxes properly stacked together to the container/wagon whichever is available with the help of diesel/battery operated forklift.
9. Packing of Security Paper Webs with edge protectors, corrugated board sheets, polythene & Kraft paper duly strapped with strapping tape before dispatch to presses with their final weight approximately around 350KG
10. Proper placing of packed Security Paper webs at Strong Room after weighing and proper markings/labels and loading those packed webs in container/wagon using available resources/machinery.
11. Unloading of Recycle packing material received from presses during return trips which shall be used for packing and dispatch purpose.
12. Diesel/battery operated fork lifter or Electric Stacker will be provided by SPM.
13. Operation of diesel/battery operated fork lifter, battery operated stacker/pallet truck and hydraulic pallet truck shall be in the scope of the firm.
14. The fork lift operator should have valid driving license for operating fork lifter.
15. Strapping tools, weighing scales and other tackles shall be provided by SPM.

16. All the packing consumables shall be provided by SPM.

17. The tentative list of work; day to day work shall be conveyed by section/shift in-charge.

18. Dress code (Shirt and Pant) along with safety shoes, Helmet, all other relevant PPEs and Photo ID card shall be provided by the contractor to each person working under this contract.

19. At start of each shift contractor shall handover the required workers at the designated area.

20. The contractor shall not change the workers frequently, before changing any persons training shall be provided to the worker by the contractor on his own expense at SPM and also intimation for the same shall be given the concern department.

21. All the safety norms and proper discipline shall be strictly followed by the contractor as well as the deputated workers.

Work execution:
