# <u>Designing, supply, installation and commissioning of fire alarm system at Godowns & Old plant areas at Security Paper Mill, Narmadapuram.</u>

Security Paper Mill (SPM, Narmadapuram) is a unit of SPMCIL a Mini-Ratna Category – I CPSE and a wholly owned schedule 'A' Company of Government of India and is under the administrative control of Department of Economic Affairs, Ministry of Finance, Government of India. It is engaged in sovereign function, production of Currency paper/Security paper.

Security Paper Mill, Narmadapuram is an ISO 9001:2015,ISO 14001:2015, ISO 45001: 2018 & ISO 50001:2018 certified unit. Also unit is NABL ISO/IEC 17025:2017 certified.

Through this EOI, eligible and experienced agencies/contractors are invited to submit their credentials for the proposed work.

#### **Scope of Work:**

- 1. Scope of work includes designing, supply, installation testing & commissioning of fire alarm system for 4 Nos of Go-downs & old plant areas.
- 2. The total area of Godowns is approx. 6,510 square meters & roof height is approx. 6-7 meters. These godowns are WRG,ERG, ERG-I & ERG-II which are used for storing the cotton bales and chemicals. Environment of this area is very dusty because of cotton dust and suspended particle.
- 3. In Old plant, we need fire alarm system in Calender-cutter section, sheet inspection section and finishing end section including strong room. The total area is approx. 10,800 square meters with roof height of 8-9 meter approx.
- 4. All the fire alarm panels are need to be connected with CISF-fire station.

#### **Eligibility and Pre-Qualification Criteria:**

- **Financial Capability:** Demonstrating last three year profit loss balance sheet.
- **Technical Expertise:** Possessing adequate design, infrastructure, and erection facilities, as well as the necessary licenses and certifications.
- **Experience:** Evidence of successful completion of similar projects within a specified timeframe, often requiring completion certificates and work orders as proof.
- **Reputation:** Firm should not be ban /blacklisted, holiday listed with any PSU, GOVT, Autonomous body.

#### **Submission Requirements:**

- **Completeness:** Bidders must submit a full and complete response, including all information requested in the EOI documents.
- **Documentation:** Providing all required forms, statements, and attachments, such as those for personnel, financial information, and technical solutions.

The Expression of Interest must be submitted with the brief profile of the firm, their past performance in similar field of designing, supply, installation testing & commissioning of fire alarm system etc. in support of the eligibility criteria.

Following document should also submit by the firm:

- 1. Letter of interest
- 2. Company profile and catalogues.
- 3. Firm should provide reference list of similar kind of activities done by them in the last 10 years in any process industry.
- 4. Audited annual reports for the last three financial years.
- 5. Firm should provide the budget estimation for project.

#### **Pre-bid Conference:**

For development of sophisticated and complex equipment, a suitable provision is to be made in the bidding documents for a pre-bid conference for clarifying issues and clearing doubts, if any, about the specification and other technical details of the plant, machinery and equipment projected in the bidding document.
