It may however be noted that there is no guarantee that full offer quantity will be ordered by the buyer. Quantity to be ordered by the buyer will depend on various factors including the Ranking of the bidder, Offered quantity, Splitting criteria indicated by the buyer in the bid and the requirement of the buyer to have multiple sources of supply for ensuring supply chain etc. Sellers would be notified about likely order quantity or range of possible order quantity at the time of price match request made by the buyer. 4. **Splitting/ Parallel Contracts:**

- a) The average annual financial turnover of the bidder during the last three years, ending on 31.03.2025, should be at least **Rs.1,86,55,800/-** as per the annual report (*audited balance sheet and profit & loss account*) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India or equivalent in relevant countries.
- b)
  - i) The net worth of the Bidder should not be negative on 31.03.2025 and also
  - ii) should not have eroded by more than 30% in the last three years, ending on 31.03.2025.

**Note for Pre-Qualification/Eligibility Criteria:**

- (i) To ascertain the financial standing criteria net worth of initial and last financial year would be compared.
- (ii) For MSEs and Start-ups (registered for the tendered item) all financial criteria shall be exempted. However

, its capacity and capability may be verified (if necessary) by the respective unit as per the standard format.

- (iii) All experience, past performance and capacity/capability related data should be certified by the authorized signatory of the Bidder firm.

Such Start-ups may be either MSE or otherwise.
  - (vii) Bidder to furnish stipulated documents in support of fulfilment of qualifying criteria. Non-submission or incomplete submission of documents may lead to rejection of offer.
  - (viii) For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of authorised representative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements (within SPMCIL/ BRBNMPL/BNPMIPL), who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past to any units of SPMCIL.
  - (ix) The bidder shall submit signed copy of Purchase order/ Work order/ Agreement/ Contract.
  - (x) SPM, Narmadapuram reserves the right to seek additional documents related to eligibility criteria like Tax invoice and documents evidencing supply of material (viz. LR/E-waybill/GSTR etc.), if required.
6. **Liquidated Damages (LD) Clause:** If the contractor fails to deliver the goods and/or services or any installment thereof within the Delivery Period, SPM Narmadapuram shall, without prejudice to other rights and remedies available to SPM, Narmadapuram under the contract, deduct from the contract price, as Liquidated damages, a sum equivalent to the rate of 0.5 Percent of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods or services.
7. The terms and conditions, guidelines of SPMCIL Procurement Manual Version 3.0 will be applicable to this bid at any stage to avoid any conflict at later stage. Kindly refer General Instructions to Tenderer (GIT) and General Conditions of Contract (GCC) of SPMCIL Procurement Manual Version 3.0 for additional terms and conditions as per the links given below:

8. SPM (as Buyer) is liable to deduct TDS u/s 194Q @ applicable rate on goods purchases (if applicable). In case of deduction of TDS under section 194Q; the Supplier (Vendor) need not to charge TCS u/s 206C (1H) on invoicing on or after 01.07.2021.

9. Vendor has to submit declaration in specified format for the compliance of Section 206AB of Income Tax Act, 1961. In case of non-submission of declaration; TDS will be deducted at higher rates (as applicable) as per section 206AB.

10. **GST Return:** Supplier should file the GST returns for outward supplies in time. SPM reserves the right to withhold the payment of further supplies till production of evidence of filing of Returns.

**11. Manufacturer Authorization Certificate:**

- (i) If the bidder firm is manufacturer then firm has to submit the valid registration certificate.
- (ii) If the bidder firm is not the manufacturer then firm has to submit the valid manufacturer's authorization certificate/valid dealership certificate of the item supplied as per the standard form duly filled by OEM as per Annexure-XIV (*refer Buyer added Specific ATC*) of this tender document.

12. Bidder shall submit duly seal & signed copy of **Technical Specifications & Quality Control Requirements**.

**13. Quality Control Requirements:**

- (i) The bidder shall confirm in their Techno-commercial Tender that the offered material shall confirm to our Technical specifications as per Section-VII and relevant I.S.S.
- (ii) Material Safety Data Sheet should be as per ISO guidelines or in the format prescribed in Factories Act, 1948. MSDS should be given along with technical bid and first supply.
- (iii) Bidder shall submit the copy of quality control records of each batch along with each supply.
- (iv) Packing standard:
  - a) Delivery of Poly Amide Resin may be taken in tanker as per requirement by SPM and unloading of the tanker is in the scope of the supplier (Pump shall come with tanker).
  - b) Delivery of Poly Amide Resin in tanker is as when as informed by SPM, other wise supply to be done as per following packing standard:

The chemical should be supplied in returnable 1000Ltr. IBC (Intermediate Bulk Container) Container: Translucent Plastic/HDPE container suitable for storage & handling of 1000Ltr. Poly Amide Resin. The Containers shall bear legibly and indelibly the following information:

- d) Month and year of packing
- e) Batch number
- f) Shelf life

14. **Delivery Schedule:** The contract shall remain valid for the period of one year from the date of issue of NAC/ GeM Contract.

- a. Material shall be taken in staggered manner. Tentative monthly requirement may be 70,000 Kg.
- b. For such staggered quantities, SPM shall intimate the supply quantity and date of delivery/ies minimum 30 days in advance through E-mail/letter.

**Note :-**

- (i) The allowable periodic variation would be +/- 5%. Under no circumstances, materials will be accepted beyond (+) 5% allowed quantity tolerance. Any variation in periodic rate of supply more than (-) 5% in each delivery schedule would be considered as delay in delivery. LD will be imposed on such short supplies beyond

and (-)5% for each delivery.

This is without prejudice to Force Majeure Clause. In any circumstances, the total Purchase Order quantity will not be exceeded.

(ii) The above delivery schedule may vary as per our requirement.

(iii) The above mentioned quantity may be divided proportionately in case of parallel contract.

**15. WARRANTY CLAUSE:**

- (i) The warranty shall remain valid for Three months from the date of last supply to the final destination and accepted by SPM in terms of the contract.
- (ii) In case of any claim arising out of this warranty, SPMCIL shall promptly notify the same in writing to the supplier.
- (iii) Upon receipt of such notice, the supplier shall, with all reasonable speed replace the defective goods or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, whatsoever shall lie on SPM for such replaced parts/ goods thereafter.
- (iv) In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of three months from the date such rectified / replaced goods starts functioning to the satisfaction of SPM.
- (v) If the supplier, having been notified, fails to rectify/replace the defect(s) within a reasonable period SPM may proceed to take such remedial action(s) as deemed fit by SPM, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which SPM may have against the supplier.

**16. SHORT CLOSE/ TERMINATION OF CONTRACT:**

The Chief General Manager, Security Paper Mill, Narmadapuram, reserve the right at any stage by giving due notice without assigning the reason:-

- (i) To short-close / foreclose/terminate the order at any time during process of supply against our supply order.
- (ii) To reduce the tender quantity at the time of concluding the final supply order/contract.

**17. OPTION CLAUSE:**

The Purchaser reserves the right to increase/decrease the ordered quantity by up to 25% at any time, till final delivery date of the contract (or the extended delivery date of the contract), by giving reasonable notice even though the quantity ordered initially has been supplied in full before the last date of Delivery Period (or the extended delivery period of the contract).

**18. Resolution of Disputes:**

If dispute or difference of any kind shall arise between SPM, Narmadapuram and the supplier in connection with or relating to the contract, the parties shall make every effort to resolve the same amicably by mutual consultations. If the parties fail to resolve their dispute or difference by such mutual consultation within 21 days of its occurrence, then, unless otherwise provided in the SCC, either SPM, Narmadapuram or the supplier may seek recourse to settlement of disputes through arbitration act 33.2.

**19. Godown Rent:**

**(i) For Rejected Material:** Any consignment which is found to be different from the specification containing contraries will not be paid for and will have to be immediately lifted by the supplier at their expenses. The rejected material, if not lifted within one month from the date of issue of communication of rejection, the supplier will have to bear Godown rent as under and that this office will not be responsible for any damages whatsoever to the consignment.

Rs.300/- per M.T. for first 15 days or part thereof after one month notice

Rs.500/- per M.T. for next 15 days or part thereof

Rs.850/- per M.T. per month after 30 days (one month) and in case of fraction of month it will be taken as full month.

In the event of not lifting rejected goods within 3 months from the date of intimation of rejection, the bidder shall forfeit their claim to the goods.

**(ii) For Empty IBC (Intermediate Bulk Container):** The firm has to immediately lift the empty IBC (Intermediate Bulk Container) at their own expenses within 1 month from the date of intimation. In the event of non-lifting of Empty IBC (Intermediate Bulk Container) within prescribed time limit, the bidder shall forfeit their claim to the goods.

## **20. Contacting SPMCIL:**

- (i)** From the time of submission of tender to the time of awarding the contract, if a tenderer needs to contact SPMCIL for any reason relating to this tender enquiry and / or its tender, it should do so only in writing.
- (ii)** It will be treated as a serious misdemeanour in case a tenderer attempts to influence SPMCIL's decision on scrutiny, comparison, evaluation, and award of the contracts. In such a case the tender of the tenderer shall be liable for rejection in addition to appropriate administrative actions being taken against that tenderer, as deemed fit by SPMCIL, in terms of clause 44 of GIT.

21. **Anti-Bribery Management System (ABMS):** By participating in this tender, the suppliers/Vendors/ Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice any such incident happening, they shall report it to Vigilance.
