7. **GST Return:** Supplier should file the GST returns for outward supplies in time. In case of any Input Credit Loss to SPM by way of their failure to file GST Returns in time, SPM reserves the right to withhold the payment of further supplies till production of evidence of filing of Returns.
8. **Delivery Period:** Within 120 days for all supply from the date of issue of GeM purchase order.

Nos of tube need to be replaced - 250 nos. Boiler tubes (approx.)

Length of Tubes- 5.95 meter

Outer Diameter- 63.50 mm

Thickness- 3.66 mm

1. The work consists of cutting the existing boiler tube from both the end plates and takes out the tube from boiler.
2. After removal of tube, tube holes grinding shall be performed by firm and the fitting of new tubes shall be ensure before welding.
3. The fit up of all tube checked by SPM representative and then clearance given for further welding.
4. Gas cutting set, welding m/c, welding electrodes (E-7018 or equivalent) and all consumable items will be in the scope of firm.
5. The required special tools and tackles like tube expander, tube cutter shall be arranged by firm.
6. Welding and workmanship shall be as per IBR guidance and having good quality standard.
7. The work has to be carried out under proper supervision.
8. All safety PPEs shall be provided by firm at work place.
9. The all safety rules and regulations shall be followed by firm and if any special instruction given by SPM safety department after observing work then same has to be follow by firm.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in सामान्य नियम और शर्तें/General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
